WHEREAS, Under **Barbara Verba's** leadership, the Department implemented the Affordable Care Act which now brings health insurance to more than 170,000 of our residents, accomplishing this expansion in access included reengineering Community Benefits business practices to establish a Call Center and developing more efficient work processes in order to manage the growth in the residents served; and
