- a. Approved Amendment No. 2 to the Agreement with Cal-West Lighting & Signal Maintenance, Inc. to allow for payment of services rendered in the amount of \$25,693 from September 1, 2017 to March 31, 2018 and to increase the not to exceed amount by \$163,500 for a total amount not to exceed \$263,500 to continue to provide services associated with traffic signal and lighting maintenance and repairs throughout Monterey County, Request for Proposals (RFP) #10475, and extend the expiration date for one (1) additional year for a revised term of November 5, 2014 to November 5, 2019;
- b. Authorized the Contracts/Purchasing Officer or Contracts/Purchasing Supervisor to execute Amendment No. 2 to the Agreement; and
- c. Authorized the Contracts/Purchasing Officer or Contracts/Purchasing Supervisor to execute future amendments which extend the term beyond the original term authorized in RFP #10475 where the amendments do not significantly alter the scope of work or change the approved Agreement amount.

AMENDMENT NO. 2 TO AGREEMENT BETWEEN COUNTY OF MONTEREY AND CAL-WEST LIGHTING & SIGNAL MAINTENANCE, INC.

THIS AMENDMENT NO. 2 to the Agreement between the County of Monterey, a political subdivision of the State of California (hereinafter, "County") and Cal-West Lighting & Signal Maintenance, Inc. (hereinafter, "CONTRACTOR") is hereby entered into between the County and the CONTRACTOR (collectively, the "Parties") and effective as of the last date opposite the respective signatures below.

WHEREAS, CONTRACTOR entered into an Agreement with County on November 5, 2014 (hereinafter, "Agreement") to provide traffic signal and lighting maintenance repair services (hereinafter, "services") through November 5, 2017 for an amount not to exceed \$60,380; and

WHEREAS, Agreement was amended by the Parties on July 10, 2017 (hereinafter, "Amendment No. 1, including Exhibit B-1 — Revised Bid Sheet/Pricing) to extend the term for one (1) additional year through November 5, 2018 and to increase the amount by \$39,620 which resulted in a total not to exceed amount of \$100,000; and

WHEREAS, due to the continued need for traffic signal preventative maintenance services in the amount of \$30,000 per year for 2018 and 2019, \$22,500 for the increased extraordinary maintenance needs for signal repair resulting from the 2017 winter storms, and \$81,000 for extraordinary maintenance during 2018 and 2019, additional time and funding are necessary; and

WHEREAS, the Parties wish to further amend the Agreement to extend the term for one (1) additional year to November 5, 2019 and increase the amount by \$163,500 for a total not to exceed \$263,500 to allow CONTRACTOR to continue to provide services identified in the Agreement and as amended by this Amendment No. 2.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- 1. Amend Paragraph 1.1 of Section 1.0, "Performance of the Agreement", to delete "Exhibit B-1, Revised Bid Sheet/Pricing" and to add "Exhibit B-2, Revised Bid Sheet/Pricing".
- 2. In all places within the Agreement, any reference to "Exhibit B, Bid Sheet/Pricing" or "Exhibit B-1, Revised Bid Sheet/Pricing" is hereby replaced with "Exhibit B-2, Revised Bid Sheet/Pricing".
- 3. Amend Paragraph 3.1 of Section 3.0, "Term of Agreement", to read as follows:

The term of this AGREEMENT is from November 5, 2014 to November 5, 2019.

- 4. Amend the second sentence of Paragraph 4.1 of Section 4.0, "Compensation and Payments", to read as follows:
 - The total amount payable by County to CONTRACTOR under this AGREEMENT is not to exceed the sum of \$263,500.
- 5. Amend the County's contact information under Paragraph 25.1 of Section 25.0, "Notices", to read as follows:

- 6. In all places within the Agreement, any reference to the County's address at 168 West Alisal Street, 2nd Floor, Salinas, California 93901 is hereby replaced with 1441 Schilling Place, South 2nd Floor, Salinas, California 93901-4527.
- 7. All other terms and conditions of the Agreement remain unchanged and in full force.
- 8. This Amendment No. 2 and the previous Amendment No. 1 shall be attached to the Agreement and incorporated therein as if fully set forth in the Agreement.
- 9. The recitals to this Amendment No. 2 are incorporated into the Agreement and this Amendment No. 2.

This provision does not apply to any policy in which the additional insured is a Named Insured on such other policy and where our policy is required by a written contract or written agreement to provide coverage to the additional insured on a primary and non-contributory basis.
