

**AMENDMENT No. 2
TO SERVICES AGREEMENT
BETWEEN Natividad Volunteer Auxiliary AND
NATIVIDAD MEDICAL CENTER
FOR
VOLUNTEER MANAGEMENT SERVICES**

This Amendment No. 2 to the Services Agreement ("Agreement"), entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and the Natividad Volunteer Auxiliary (hereinafter "CONTRACTOR"), with respect to the following:

RECITALS

WHEREAS, the Agreement was executed for Volunteer Management Services with a one year term of September 1, 2014 through August 31, 2015 with a total Agreement amount not to exceed \$97,000; and

WHEREAS, NMC and CONTRACTOR amended the Agreement on June 16, 2015 via Amendment No. 1 to extend the term for an additional three (3) year period through August 31, 2018 and to add an additional \$ 291,000, thereby increasing the total Agreement amount to \$ 388,000; and

WHEREAS, NMC and CONTRACTOR currently wish to amend the Agreement to extend it for an additional three (3) year period through August 31, 2021 to allow for services to continue for a full Agreement term of September 1, 2014 through August 31, 2021 with a \$310,000 increase for a total Agreement amount of \$698,000

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby amended on the terms and conditions as set forth in the Original Agreement and incorporated herein by this reference, except as specifically set forth below.

1. Section titled, "PAYMENTS BY NMC" shall be amended to the following; ***"NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in EXHIBIT A. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$698,000."***
2. The first sentence of the Section titled "TERM OF AGREEMENT" shall be amended to the following; ***"The term of this Agreement is September 1, 2014 to August 31, 2021 unless sooner terminated pursuant to this Agreement"***
3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the Agreement.
4. A copy of this Amendment No. 2 shall be attached to the Original Agreement.

IN WITNESS WHEREOF, the parties hereto are in agreement with this Amendment No. 2 on the basis set forth in this document and have executed this Amendment No. 2 on the day and year set forth herein.
