

AMENDMENT NO. 1 TO AGREEMENT BY AND BETWEEN COUNTY OF MONTEREY & HARRIS CORPORATION

THIS AMENDMENT No. 1 is made to the AGREEMENT for Software FX security management services for the Next Generation Radio System (NGEN), by and between Harris Corporation, hereinafter “CONTRACTOR”, and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as “COUNTY.”

WHEREAS, the County and CONTRACTOR entered into an agreement on March 20, 2017, by which CONTRACTOR is to provide Software FX security management services for the County’s Next Generation Radio System in the amount of \$436,000; and

WHEREAS, the County and CONTRACTOR wish to amend the AGREEMENT to add additional funding in the amount of \$5,042.00 to pay taxes on taxable software products, for a total contract amount not to exceed \$441,042.00;

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:




