WHEREAS, in preparation for the FY 2017-18 fiscal year-end close, the County Administrative Office (CAO) has prepared an analysis of budget to actuals by appropriation unit and identified two of the CAO General Fund appropriations units are anticipated to exceed appropriations; and

WHEREAS, the CAO Administration & Finance Appropriation Unit CAO001 is expected to exceed appropriations by \$90,149 due primarily to an overage in salary and benefits; and

WHEREAS, the Office of Community Engagement & Strategic Advocacy (OCESA) Appropriation Unit CAO024 is expected to exceed appropriations by \$22,504 due to overage in grant expenditures which are financed by grant revenue; and

WHEREAS, several CAO appropriations are anticipated to come in under budget and therefore appropriations can be reduced by decreasing Fleet Administration CAO025 by \$90,149.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of Monterey hereby:

- 1. Authorize the Auditor-Controller to amend the FY 2017-18 Adopted Budget by increasing appropriations in the amount of \$90,149 in the County Administrative Office (001-1050-CAO001-8045), offset by a \$90,149 decrease in appropriations in the County Administrative Office (001-1050-CAO025-8451 (4/5ths vote required); and
