

**AMENDMENT #2 TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE COUNTY OF MONTEREY
&
KELLY DUNCAN**

THIS AMENDMENT is made to the AGREEMENT for legal representation services by and between Kelly Duncan, hereinafter "Attorney", and the County of Monterey, a political subdivision of the State of California, hereinafter referred to as "County".

WHEREAS, the County and Attorney have executed Amendment No. 1 to the Agreement to extend the term of the agreement through June 30, 2019, and to increase the total amount of the AGREEMENT by \$84,000.00 to compensate Attorney for the period of July 1, 2018 through June 30, 2019; and

WHEREAS, the County and Attorney wish to amend the Agreement to change the insurance provisions of the Agreement.

NOW THEREFORE, the County and Attorney hereby agree to amend the AGREEMENT in the following manner:

1. Exhibit C, attached to this amendment No. 2, shall be added to the Agreement, deleting the requirement that Attorney provide an endorsement naming the County as an additional insured on her automobile insurance policy.
2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by the AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
3. A copy of this AMENDMENT #2 shall be attached to the original AGREEMENT executed by the County on July 25, 2017.

EXHIBIT-C

**To Agreement by and between
the County of Monterey (County)
AND
Kelly Duncan ("Attorney")**

Attorney's automobile insurance carrier is Farmers Insurance Exchange, which will not provide her with an endorsement to her automobile insurance policy, naming the County as an additional insured. The parties agree that Attorney will not be required to provide County with an endorsement to her automobile insurance, naming it as an additional insured, notwithstanding Paragraph 7.02 of the Agreement. Attorney agrees to provide a Certificate of Insurance, indicating automobile coverage in the required amounts as specified in Paragraph 7.02, and to maintain such coverage continuously throughout the term of the Agreement, as specified in Paragraph 7.02.
