WHEREAS, Sunday Berlanga began her career with the County of Monterey at the Planning and Building Inspection Department as a Typist Clerk II on August 27, 1984, with progressive promotions to Senior Typist Clerk on December 9, 1984, Department Data Processing Technician on April 9, 1988, Supervising Department Data Processing Coordinator on June 13, 1992 and to a Supervising Department Information Systems Coordinator on September 12, 1998; and

WHEREAS, Sunday Berlanga when transferred to the Health Department/Behavioral Health Bureau was promoted to a Supervising Department Data Processing Coordinator in 1992 as the sole staff member overseeing Information Systems and the Medi-Cal, Medicare, and private insurance billing for the Bureau; and

WHEREAS, Sunday Berlanga when reclassified during her tenure with the Health Department/Behavioral Health Bureau to a Supervising Department Information Systems Coordinator in 1998, continued to be the Liaison between the State Department of Health Care Services and the Behavioral Health Bureau providing client data for mental health and substance use disorder services meeting compliance with the State's requirements and providing statistical data; and

WHEREAS, Sunday Berlanga trained and assisted staff members and contract providers with troubleshooting and making improvements with data input and reports using the Legacy VAX software application system, and continued to provide this assistance with an upgraded software application system Avatar for Electronic Health Records, in addition to providing assistance with Microsoft applications, creating databases and reports; and

WHEREAS, Sunday Berlanga consistently displayed expert program knowledge, excellent quality customer service throughout her career including providing assistance in quality improvements, and was most gratified and rewarded by helping staff and contract providers with software application issues; and

WHEREAS, Sunday Berlanga was very appreciated by staff members and contract providers for her invaluable assistance with software application systems; and

WHEREAS, Sunday Berlanga had a 34 -year career with County of Monterey and now wishes to pursue her personal interests as a jewelry business consultant and spending more time with family.
