WHEREAS, On September 28, 2018 through September 30, 2018 the California Airshow will be celebrating its 38th anniversary; and

WHEREAS, this year, as the Air Show includes flying of the United States Air Force Thunderbirds aircraft, the Federal Aviation Administration (FAA) requires a high speed acrobatic box that is sterilized (cleared of all persons) on Friday September 28, 2018 from 2:30 until 5:00 p.m.; and

WHEREAS, the FAA designated corridor includes County offices located on LaGuardia Street, housing certain units for the County's Department of Child Support Services, Department of Social Services (including One-Stop Center) and the Office of Employment and Training, which will need to be closed and cleared of persons on Friday September 28, 2018 from 2:30 until 5:00 p.m.; and

WHEREAS, the closure of designated County offices requires Ordinance No. 766, fixing the days and hours of operations of County offices, to be waived for the purposes set forth herein;

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors in and for the County of Monterey as follows:


