NOTICE OF PUBLIC HEARING PURSUANT TO SECTION 147(f) OF THE INTERNAL REVENUE CODE OF 1986 FOR THE FINANCING OF CERTAIN FACILITIES FROM THE SALE OF TAX-EXEMPT BONDS

NOTICE IS HEREBY GIVEN that at 10:30 a.m., or as soon thereafter as the matter may be heard, on October 23, 2018, at Monterey County Government Center, Board of Supervisors' Chambers, 168 W. Alisal Street, 1st Floor, Salinas, California, 93901, the Board of Supervisors of the County of Monterey (the "Board") will conduct a public hearing (the "Public Hearing") at which the Board will hear and consider information concerning the proposed issuance by the Monterey Regional Waste Management Authority (the "Authority") of one or more series of revenue bonds from time to time in an aggregate principal amount not to exceed \$25,500,000 at any one time outstanding (the "Bonds") to finance for the Monterey Regional Waste Management District (the "District") the design, acquisition and construction of improvements to the District's solid waste disposal and recycling system and related facilities (the "Project"), located at 14201 Del Monte Boulevard in unincorporated Monterey County, near the City of Marina, California. The Bonds will be part of a plan of finance, which may occur over a period of multiple years. The Project will initially be owned and operated by the District.

The Bonds shall be a limited obligation of the Authority, payable solely from certain revenues duly pledged therefor and generally representing amount paid by the District. Neither the faith and credit nor the taxing power of the County of Monterey (the "County"), the Authority, and its members, the District, the State of California (the "State"), or any other political corporation, subdivision or agency of the State is pledged to the payment of the principal of, premium, if any, or interest on, the Bonds nor shall the County, the Authority and its members, the District, the State or any other political corporation, subdivision or agency of the State be liable or obligated to pay the principal of, premium, if any, or interest on, the Bonds. The Public Hearing is intended to comply with the public approval requirements of Section 147(f) of the Internal Revenue Code of 1986.

Those wishing to comment on the issuance of the Bonds, proposed nature and location of the Project or the plan of finance may either appear in person at the time and place indicated above or submit written comments, which must be received prior to the Public Hearing by the County of Monterey, Attention: Clerk of the Board of Supervisors, P.O. Box 1728, Salinas, California 93902.
