Upon motion of Supervisor Phillips, seconded by Supervisor Adams and carried by those members present, the Board of Supervisors hereby:

- a. **Agreement No.: A-14152** / Approved and authorize the Director of Health or Assistant Director of Health, and the Emergency Medical Services (EMS) Agency Director to execute the County of Monterey, Department of Health, Emergency Medical services Agency Agreement with ESO and Providers for Reporting to California Emergency Medical Services Authority between the County and those EMS provider agencies intending to participate in the County's Unified Electronic Patient Care Reporting (ePCR) and Data System for first responders, ambulance transport providers, hospitals, and communications centers, for a period from the date of approval and execution by the participating parties through March 30, 2020; and
- b. Approved and authorize the Director of Health or Assistant Director of Health, and the Emergency Medical Services (EMS) Agency Director to execute the County of Monterey Emergency Services Agency Agreement with EMS Providers (**Agreement No. A-14153** with CALFIRE, **Agreement No. A-14154** with Cachagua FPD, **Agreement No. A-14155** with City of Carmel FD, **Agreement No. A-14156** with Gonzales Rural FPD, **Agreement No. A-14157** with Greenfield Fire, **Agreement No. A-14158** with Monterey City Fire, **Agreement No. A-14159** with Presidio of Monterey Fire, **Agreement No. A-14160** with Seaside Fire, **Agreement No. A-14161** with Salinas Fire, **Agreement No. A-14163** with Big Sur VFB, **Agreement No. A-14164** with Mid Coast FB and **Agreement No. A-14165** with American Medical Response) intending to participate in the County's Data System for Quality Assurance/Quality Improvement (QA/QI) Oversight and Data Collection/Aggregation. 
