AMENDMENT NO. 1 TO THE SERVICES AGREEMENT BETWEEN NATIVIDAD MEDICAL CENTER AND

MARTIN MARTIN INC./DBA: MEDICAL EDUCATION SPEAKERS NETWORK

This AMENDMENT NO. 1 to the Services Agreement ("Agreement"), dated April 1, 2016 is entered into by and between the County of Monterey, on behalf of Natividad Medical Center (hereinafter "NMC"), and Martin Martin Inc./DBA: Medical Education Speakers Network, (hereinafter "CONTRACTOR"), collectively referred to hereinafter as "the Parties", with respect to the following:

RECITALS

WHEREAS, the Parties had previously entered into an Agreement on April 1, 2016 for the provision of professional speakers for provider CMEs services for NMC, in an amount not to exceed \$15,000; and

WHEREAS, the Parties wish to amend the Agreement to extend the Agreement term for an additional one year, for a revised full term of April 1, 2016 through March 31, 2018 and to add additional funding in the amount of \$15,000, for a total amount not to exceed \$30,000.

AGREEMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

The Agreement is hereby amended on the same terms and conditions as set forth in the Original Agreement, except as specifically set forth below.

- Paragraph titled "PAYMENTS BY NMC, second sentence, shall be amended to the following: The total amount payable by NMC to Contractor under this Agreement shall not exceed the sum of \$30,000.
- 2. Paragraph titled "TERM OF AGREEMENT, first sentence" shall be amended to the following: The term of this Agreement is from April 1, 2016 through March 31, 2018 unless sooner terminated pursuant to the terms of this Agreement.
- 3. Except as provided herein, all remaining terms, conditions and provisions of the Agreement are unchanged and unaffected by this Amendment No. 1 and shall continue in full force and effect.
- 4. A copy of this Amendment No. 1 shall be attached to the Original Agreement.
- 5. This Amendment No. 1 shall be effective upon signing of both parties, with NMC signing last.
