- b. Authorize the execution by the Chairperson of the Agency Board of Supervisors and Chairperson of the Board of Directors of a Memorandum of Agreement with the California Department of Fish and Wildlife containing the recommended terms and authorizing the execution of the MOA, with such other terms and provisions as deemed necessary or appropriate by Agency negotiators (as approved by Water Resources General Manager, Chairpersons of the Boards of Supervisors and Board of Directors, and County Counsel), and other necessary documents and certificates and related actions; and
