

a. Receive a follow up report on the update to Article V - Parks User Fees of the Monterey County Fee Resolution (Park User Fees); and

b. Support recommended updates to the Board of Supervisors regarding Park User Fees.

### **RECOMMENDATION:**

It is recommended that the Park Commission:

Support recommended updates to Article V - Parks User Fees of the Monterey County Fee Resolution (Park User Fees).

#### SUMMARY/DISCUSSION:

Article V - Parks User Fees of the Monterey County Fee Resolution (Park User Fees) has not been updated since September 30, 2014. The Resource Management Agency (RMA) identified a need to reorganize and update Parks User Fees. On June 7, 2018, staff presented to the Parks Commission a report on the park fees and proposed updates to Article V which included a revision to the existing Park User Fees format, including adjustments to existing fees, additions and deletions of other fees. At this meeting the Parks Commission recommended incorporating the following changes:

- Remove the issuance of annual passes by calendar year basis and replaced with 12 months from month of purchase
- Modify annual escalator for day use fees to every two years with a not-to-exceed of \$5.
- Add an application fee for park projects to recover staff costs
- Add a discount for students
- Add no entry fee for children under 5 years old

The Parks Commission approved staff to move forward to the Board of Supervisors, with above changes incorporated, so as not to delay the Park User Fees updates, if the July 5, 2018 Parks Commission was cancelled. The July 5, 2018 Parks Commission was cancelled, so staff incorporated the Parks Commission updates and scheduled a presentation to the Board of Supervisors on July 17, 2018. On July 15, 2015, the Board of Supervisors received a request for the Park User Fees matter to return to the Parks Commission for final consideration. As a result, the Park User Fee update was pulled from the Board of Supervisor's agenda. On August 28, 2018 staff will be presenting the Board of Supervisors with a recommendation to adopt a Resolution to amend Article V - Parks User Fees of the Monterey County Fee Resolution effective October 1, 2018, to adjust and establish new fees relating to Parks User Fees (**Attachment C**).

The following is the report that was prepared for the Board of Supervisors, which incorporated items

discussed by the Parks Commission at the June 7, 2018 meeting:

Staff proposes changes to both the organization and content of the current fee schedule:

- Organization. Fees are organized by County park, leading to inconsistencies and duplication of
  fees, creating confusion, and making it difficult for staff to implement. For instance, there are
  currently 10 different day-use vehicle entry fees on the fee schedule ranging from \$5 to \$15.
   Removing reference to specific parks allows staff to apply fees when new parks are added
  like the County-owned open spaces lands and the Travel Camp in the former Fort Ord area.
- 2. Content. In working with the current Article V, RMA identified several park activities for which there is no fee established, such as walk-in or bike-in entry for day use. Also, some fee units are difficult to implement and erosive of fee value, such as vehicle entry included in the price for group picnic areas. These content issues are contributing to a troubling state of Parks finances. Staff is proposing changes that create opportunities to recover overlooked costs.
- 3. <u>Inconsistencies</u>. Upon review of the current fee schedule, staff uncovered several inconsistencies between policy set by Chapter 14.12 of the Monterey County Code, and policy language included in Article V. These amendments seek to strip all policy items from Article V and to clarify any inconsistencies. Concurrently, staff is updating Chapter 14.12 so all fee policies align.

This reorganization is designed to make Article V easier to navigate, consolidate the same fees associated with multiple parks, and provide flexibility for adding new park/open space lands.

Staff has prepared amendments that reorganize Article V, and add and delete fees to recover costs related to the use of County parks. While Laguna Seca Recreation Area, Lake Nacimiento, and Lake San Antonio are currently managed under management agreements with third parties, the fees associated with their operations have been incorporated in the proposed amended Article V.

The amended Article V more closely reflects, while still not exceeding, the actual and reasonable costs of services and benefits provided to the public. Staff has provided information specific to each amendment that can be found in **Attachment A**.

RMA-Parks consists of two separate operating units: Park Operations, Fund 001-Unit 8475, includes the County day use Park facilities, such as Toro Park, Manzanita, Royal Oaks, Jacks Peak, as well as San Lorenzo Park. Lake Operations, Fund 452-Unit 8477, is an enterprise fund and includes Lake Nacimiento and Lake San Antonio.

The FY 2017-18 Modified Budget for Parks Operations reflected \$3,764,235 in appropriations, which included the increase of \$268,478 in appropriations approved on June 26, 2018 by the Board of Supervisors, as well as an adjustment for COWCAP of \$325,822. The recent need to increase appropriations in Park Operations in addition to the COWCAP, was attributed to an increase in building, equipment, and vehicle maintenance resulting from the accumulation of deferred maintenance, as well as damage sustained from winter storms and drought. The FY 2017-18 revenue projection for

Park Operations was \$961,977 versus the modified adopted budget of \$1,266,455 leaving the need for the County General Fund contributions of \$2,802,258 to balance the budget. Staff is recommending modifications to Article V to assist in offsetting the increases in costs of services. The significant change recommended to Article V for the Day Use Parks is the frequency of charging patrons that visit the County Day Use Parks. Currently there is no daily entry fee for individuals entering the Parks when not in a vehicle, except on Holidays or during Special Events. Changing the current Article V to create a daily entry fee anytime the Day Use Parks are open to the public will assist to increase revenues that will be used within the Day Use Parks to offset the costs of operations and maintenance. Based on the daily entry counts that have been taken at Toro Park alone, staff anticipates an increase in receipts of at least \$300,000 annually. To accommodate patrons that frequently visit County Parks, staff is recommending Park specific annual passes at half the cost of the current annual Parks pass. Currently annual Park passes are valid at all County Parks, except for Lake Nacimiento.

The FY 2018-19 Adopted Budget for Park Operations was developed using the expenditure trends for maintenance as experienced in FY 2017-18, as well as incorporating increased costs for salaries and benefits resulting in an appropriations budget of \$3,779,134. In anticipation of staff bringing forward the Article V update, staff included an assumption to increase budgeted revenues to \$1,269,283 or \$307,306 above projected FY 2017-18 revenues of \$961,977 in order to maintain FY 2017-18 levels of service. By incorporating an increase in fees generated by changes to Article V, the general fund contributions needed to balance the Parks Operations in FY 2018-19 is expected to decrease and for FY 2018-19 is slightly lower than the prior year at \$2,509,851. Staff is confident that the fee article update will reduce the need on the general fund contribution for Park Operations, however, will not generate sufficient revenues to fully cover the operation and maintenance costs for the Day Use Parks and that there will still need to be a significant contribution from the general fund to balance the budget in the future.

There are no significant changes to the fees currently being charged at the Lakes Operations. Staff is proposing adding a new rate for Hikers/Bikers (non-motorized), as well as an increase of \$3 to existing camping rates. The change in the camping rates will align with the camping rates as San Lorenzo Park. The Article V update for the Lakes Operations has been expanded to include the rental rates for the Lodges and Boating.

While it would have been desirable to possess specific counts associated with each line item within the Fee Article, this information was not available. Where available staff conducted a comparison and there were not substantial increases that demonstrated fees would fully cover operating and maintenance costs for the County Park Facilities.

To further ensure the proposed fees are reasonable, staff also compiled a comparative analysis of fees established in comparable jurisdictions. These jurisdictions included Santa Clara County, Santa Cruz County, San Luis Obispo County, the City of Monterey, Point Lobos State Park, Salinas County Fairgrounds in King City, private RV parks, Shasta-Trinity State Park, and the City of Hollister. While none of the jurisdictions were able to provide comparable data for every line item in Article V, staff was able to gather three to four comparable data points for most line items from across all of these jurisdictions.

Parks fees are authorized by state law pursuant to Government Code section 50402. By definition, the changes to these fees are not a "tax" and are exempt from voter approval pursuant to Article XIII C, section 1(e), subpars. (1)-(5) of the California Constitution (Proposition 26, excepting certain fees and charges from the definition of "tax"). As such, they reflect no more than the actual cost of the service/benefit received by the payor.

Staff requests the Board of Supervisors adopt the attached resolution to amend and establish new fees in Article V of the Monterey County Fee Resolution in order to recover costs related to the use of County parks. Fee amendments become effective 30 days after adoption.

#### OTHER AGENCY INVOLVEMENT:

RMA worked with the Office of County Counsel and the Office of the County Administrative Office.

#### FINANCING:

Staff acknowledges that user fees are established to offset some or all the cost of services, and do not exceed actual costs for providing these services. The proposed fee adjustments will offset actual expenditures incurred associated with the proposed fees. The FY 2018-19 Adopted Budget includes anticipated revenues from the proposed fee adjustments. This action will have no negative impact on the General Fund Contributions for these services.

When necessary, RMA intends to bring a future update to the fee schedule that will reflect Board of Supervisors' General Financial Policy number 7.4, User Fees, directing that "all fees be reviewed as necessary and adjusted (as necessary). The full cost of providing a service is calculated to provide a basis for setting the charge or fee. Full cost incorporates direct and indirect costs, including operations and maintenance, overhead, charges for the use of capital facilities, as well as depreciation."

#### **BOARD OF SUPERVISORS STRATEGIC INITIATIVES:**

Parks are intended to provide a safe environment for people to achieve their potential, leading businesses and communities to thrive and grow by reducing violent crimes as well as crimes in general. Parks require a certain level of financial stability to continue offering opportunities for outdoor recreation and green space, in support of healthy lifestyles and the environment. Establishing appropriate Park fees ensures that RMA can respond to customer preferences and recover costs for the use of parks infrastructure.



# Attachment A



To better organize and clarify the structure of Article V, staff recommends eliminating the per park organizational structure and consolidating like fees where possible, adding new fees, eliminating certain fees, and redefining fees.

Staff recommends several modifications to specific line items in the current fee schedule. The amendments to the existing line items are detailed below.

### **Amendments to Section 1 – Administrative Fees**

"General Provisions" – staff recommends renaming this section to "Administrative Fees" because the items covered in this Section are not specific to a Park facility, rather they apply in general.

"Reservation Fee" – staff recommends this term be replaced with "processing fee" to be more descriptive of the types of services this charge applies to, making it clear that the charge can apply to staff time related to customer service such as processing reservations, annual passes, permits, or special events.

"Cancellation Fee" – applicable to the cost of time to research the reservation, review the transaction, complete a refund request, route for signature, and process a refund. The cancellation fees were reorganized per input from Parks staff regarding implementation hurdles.

"Penalty Fee" – applicable for non-payment of day use, camping, or boating fees. Section 1 item "C" in the proposed schedule was increased from \$25 to \$35 and assumes the cost of time to verify amount due, gather information from non-paying individual, prepare an invoice and accompanying memo (if after the fact), tracking status, recording receipt, removing delinquent transaction out of system, and processing payment.

"Returned Check Fee" – applicable for returned checks with nonsufficient funds. Section 1 item "D" was increased from \$25 to \$35 to be consistent with the rate charged by the Treasury Tax Collector.

"Specialty Fee" – applicable for Mills Action Application Processing Fee for Historic Resources Review Board (HRRB) review. Section 1 item "E" from the current schedule was removed from Article V. This review has been moved under Planning within the Land Use and Community Development Division of the RMA.

"Supervision" – applicable as needed for use of parks during non-peak operating hours. Section 1 item "F" in the current schedule was modified to "On-Site After Hours Facility Support" to be more descriptive of the types of services this charge applies to, making it clear that the charge applies to any use of parks that occurs outside normal business hours. Rates charged will be based on actual County costs, including staff time and materials needed to support the use of parks outside normal business hours not to exceed \$150 per hour. As such, this will vary according to the available staff member's fully burdened labor rate, including overtime rates or if we need to contract outside services.

"Gift Card Service Fee" - Section 1 item "L" of the current schedule was removed from the fee

article as this fee is obsolete.

"Jump House/Inflatables Use Permit Fee" – previously identified under Section 6 – Toro & Royal Oaks Park, Line item "C". This item was moved to Section 1- Administrative Fees and renamed to clarify that it applies to any special activity or equipment including but not limited to: air bungee jumpers, bounce houses, human hamster balls, rock climbing walls, and other special park facility uses.

### Amendments to Section 2 – Day Use Fees

"Annual Day Use Pass" - Section 1 item "G" ("Annual Day Use Pass") was moved to Section 2 – Day Use Fees as part of the schedule reorganization. This fee covers admittance to all parks, excluding Lake Nacimiento and Laguna Seca Recreation, however it includes a 50% discount on day-use entrance fees at Lake Nacimiento. Additionally, the pass is valid for up to four people per household.

"Annual Dog Pass" - Section 1 item "H" ("Annual Dog Pass") in the current schedule was renamed to "Annual Household Pet Pass" and was modified to raise the fee from \$20 to \$35. This pass, while not purchased often, traditionally it is purchased at the same time annual day use passes are purchased and usage exceeds twenty days out of the year. These passes are predominantly sold at Lake Nacimiento. The unit was clarified to be valid for 12 months from the date of purchase. This item was moved to Section 2 – Day Use Fees as part of the schedule reorganization.

"Household Pets" – previously identified under Sections 2-5 under camping at Lake San Antonio, Lake Nacimiento, Laguna Seca, and San Lorenzo, several line items regarding dogs were condensed and moved to Section 2 – Day Use Fees as part of the schedule reorganization. The definition for Household Pets has been added to the Ordinance. The fee unit was also modified to remove the reference to a \$10 maximum, and the policy reference regarding a limit of two dogs was removed.

"Horses" – previously identified under Section 2, Line item "J" North Shore Equestrian Area, this item was moved to Section 2 – Day Use Fees as part of the schedule reorganization. The current fee article only identifies horse fee for the North Shore Equestrian Area, yet horses are allowed in day use and camping areas. The fee was raised from \$3 to \$5 to reflect the higher cost of cleanup associated with horses.

### **Amendments to Section 3 – Camping Fees**

One of the most significant changes proposed in the new schedule is the shift from park specific camping fees to a more general fee based on campsite amenities. It should be noted that campsites for hikers/bikers were previously not addressed in the fee schedule and are being proposed in this resolution. See below for details.

"Discounts for Camping" - Section 1 item "J" in the current schedule was modified to delete the discounts for off-season camping, due to an inconsistency between the off-season dates listed in the ordinance. The discount for military personnel was expanded to include both active and retired personnel.

"Distinguished Veterans" – requires California State Department of Parks Distinguished Veterans pass. Section 1 item "K" in the current schedule was modified and moved into the sections on day use and camping to remove the off season rates and was condensed with all fees waived, except during special events. There is a limit of five days per month for the camping discount.

"Firewood" – administrative fee includes handling and delivery costs. Section 1 item "M" was modified to remove administrative fee. Added flat rate of \$10 per bundle for purchase of firewood. This item was moved to Section 3 – Camping as part of the schedule reorganization.

### Amendments to Section 4 – Boating Fees

"Boating" – Section 1 item "I" ("Boating") in of the current schedule was moved to Section 4 – Boating as part of the schedule reorganization. The annual Houseboat fee was raised to \$1,620 to reflect the rates currently being charged and to cover the quagga mussel inspection required for lake usage. This item applicable only to Lake San Antonio and Lake Nacimiento.

### **Amendments to Section 6 – Picnic Area Rental Fees**

**Group Picnic Area Rentals:** This modification condenses the existing 18 line items pertaining to group picnic area rentals down to 8 items. Rental fees are organized by seating capacity into categories ranging from small (max 50 people) to XX-Large (max 500 people). Staff recommends this organization rather than site-specific fees because it will easily accommodate additions or deletions of County picnic areas without the need to amend Article V.

The fee units pertaining to group picnic areas were also modified to remove the references to vehicle entry as the new fee structure moves to a per person rather than a per vehicle entrance fee structure.

The line items pertaining to deposits were renamed "Damage Deposit" and were reorganized into three categories, based on the maximum occupancy of the picnic area.

### **Amendments to Section 7 – Building Rental Fees**

**Building Rentals:** This modification condenses the existing 5 line items pertaining to building rentals down to 3 items, excluding Laguna Seca and the Lakes. Rental fees are organized by seating capacity into categories ranging from small (max 25 people) to Extra-Large (max 400 people). Staff recommends this organization rather than site-specific fees because it will easily accommodate additions or deletions of County parks buildings without the need to amend Article V.

### Amendments to Section 8 – Laguna Seca Race Track Rental Fees

In this section, the fees were raised slightly to account for inflation, rising upkeep, and staffing costs. Several policy items were removed. Section 8, item E (Associated Track/Paddock Rental Costs) was removed as these items are administered and assessed through the rental contract process.

"All Twenty (20) Bays" –Item H.3. was raised from \$1,000 to \$4,000 upon the recommendation of Laguna Seca staff. The 80% discount provided in the current fee schedule is preventing full

cost recovery for the use of this venue space. The proposed fee increase still provides a good value discount at 20% while recovering much more of the costs to maintain the garage bays.

### Amendments to Section 9 – Laguna Seca Rifle and Pistol Range Fees

In this section, the fee amounts are modified as follows:

- First Hour  $\rightarrow$  raised from \$11 to \$15
- Test Fire -10 minutes  $\rightarrow$  raised from \$7.50 to \$8
- o Club Event → raised from \$10 to \$15 per person

### **Amendments to Section 10 – Photography Permit Fees**

"Annual Photography Permit" – Section 9, Item A. of the current fee schedule was modified to raise the fee from \$100 to \$500. The unit was clarified to remove the reference to an included vehicle as the entry fee structure has changed to a per person, instead of per vehicle charge. The cost for the annual photography permit now will include an annual day use pass.

Each existing line item in Section 9 was clarified to specify that the fee applies to commercial, or "for-profit", photography as opposed to recreational or nonprofit. See below for details on new fees established for nonprofit photography. It should be noted that this fee does not apply to drone photography.

This resolution seeks to establish new fees. The new fees established in this resolution are detailed below.

### The following are new fees added to Section 1 – Administrative Fees:

"Security Services" – This fee was added to recover costs when the nature of park use is such that additional security is necessary (e.g. alcohol permits, large parties). This new line items pertains to day-use parks (Toro, Royal Oaks, Manzanita, Jacks Peak) that ban alcohol except in designated areas, as well as San Lorenzo Park. The need for requiring security is to augment County resources. The rate and unit charged for this service will be based on current negotiated contractual agreements for Security Guard services. The schedule of current rates is included as an attachment to this report.

"Sports Equipment Rental" –This fee was added to recover costs associated with the rental and upkeep of sports equipment, such as soccer balls, volleyballs and horseshoes. Prior practice was the Parks Foundation administered sports equipment rental, however the sustainability of this arrangement is no longer feasible and as such the RMA will be taking on this responsibility.

"Volleyball Net Rental" – This fee was added separately from the above referenced sports equipment rental line item above due to the higher cost of volleyball nets in comparison to other sports equipment rented at County parks.

"Wedding Fee" – is a new line item that includes a 1 day photography permit, 3-hour rehearsal but does not include daily entry fees.

"Convenience Fees" are two new line items added to facilitate online and in-person credit card

payments.

"Processing Fee for Parks Gifts, Contributions, or Donations" – This line item was added to recuperate staff costs associated with accepting gifts, contributions or donations to County parks. It is assessed as a nonrefundable deposit.

### The following are new fees added to Section 2- Day Use Fees:

"Annual Day Use Pass – Park Specific" – This fee was added to provide a new annual park pass option to the public. For the \$40 fee, a member of the public can choose one park (Toro, Royal Oaks, Jack's Peak or San Lorenzo) for unlimited visits during a year (from time of issuance). It should be noted that this fee was added in part due to the direction provided from the Board upon the adoption of the last update to the parks fee schedule in Resolution 14-093 on September 30, 2014.

"Day Use Fees" — The most significant change in the proposed fee schedule is a shift from a vehicle based day use entry fees to a per person entry fee for most parks (Toro, Jacks Peak, Royal Oaks, San Lorenzo). The \$2 per person entry fee, charged regardless of how a patron enters the park (e.g. walk, bike or drive) is meant to address patterns of fee nonpayment that have been noticed by park staff. Staff feels this change will ensure that costs for every patron using the park will be recovered. It should be noted that Laguna Seca Recreation Area will still be covered by a vehicle entry fee. This fee item does not apply to Manzanita Park, as entry is managed by the North County Youth Recreation Association, as this Park is used mostly for organized sports.

Additionally, the RMA is seeking authorization to include an automatic biennial fee escalator of \$1 to the Day Use Fee, not to exceed \$5. Under this proposal, the established \$2 per person walk-in entry fee that is currently only assessed for holidays and special events will apply to all park visitors (e.g. walk, bike or drive) for the next two years. Starting in 2020 and every two years following, the fee would increase by \$1 until a rate of \$5 is achieved.

Additionally, RMA is seeking authorization to waive the walk-in day use entry fee for children under five years old. Under this proposal, the day use entry fee would only be charged per person five years old and over. This proposal is included on the recommendation of the Parks Commission, which expressed concerns related to the affordability of the parks with the introduction of the non-holiday/special event per person entry fee.

"Student Entry" – This line item was added during the June 7, 2018 Parks Commission meeting regarding how the revised per person day use entry fees might impact student athletes who use County parks to practice and to participate in competitions. Under this proposal, students with a valid student ID are allowed into Toro, Jacks Peak, Royal Oaks, and San Lorenzo parks at a reduced rate of \$1.

### The following are new fees added to Section 3 – Camping Fees:

"Campsite –Hiker/Biker" – This fee is established to allow for a new type of camping in San Lorenzo Park and potentially at the Lakes. To meet demand for camping in peak times, RMA

would like to offer camping outside the developed campsites, but within designated areas, to visitors entering the park on foot or by non-motorized bicycles. RMA intends to establish written procedures regarding Hiker/Biker camping and will not implement this fee until the procedures have been established. The \$15 fee would cover the costs of facility use by this type of visitor and would not include vehicle entry to the park.

Several new line items pertaining to camping related rentals at Lake Nacimiento and Lake San Antonio were added.

### **Section 4 – Boating Fees:**

Section 4 was added to the fee schedule in order to cover boat rentals available at Lakes Nacimiento and San Antonio. Several boating related items that are currently under general provisions section are moved to this section.

### **Section 5 – Lodging Fees:**

Section 5 was added to the fee schedule in order to cover lodging rentals available at Lakes Nacimiento and San Antonio.

### The following is a new fee added to Section 8 – Laguna Seca Race Track Rental Fees:


"Ten (10) Bays" – Item H.2. was added to provide an additional bulk discount option for renting a half of the available garage bays. This item provides a 20% discount.


### The following are new fees added to Section 10 – Photography Permit Fees:

Section 9 of the current fee schedule was renumbered and expanded to include four new fee items related to nonprofit photography and filming. The current fee schedule does not distinguish between commercial and nonprofit photography. Under the proposed schedule, nonprofit portrait photography, still photography, television advertisements/videos or movie/television productions would be charged a fee that is 50% lower than that of commercial photography.

### The following are new fees added to Section 11 – Special Event Fees:

Section 10 of the current fee schedule was renumbered and expanded to include a new line item for chemical toilets and handwashing stations. This fee was added to recover costs when portable sanitation facilities must be rented to accommodate crowds more than what can be serviced by existing park restroom facilities infrastructure. The rate and unit charged for this service will be negotiated per special event.

### 2. Assignment of Costs to Permittee:

In the event that the Parks Department incurs excess costs for the operation of the park unit as a result of the special event, these costs shall be assigned to Permittee. Such costs shall include, but not be limited to, directing/parking traffic, providing security, providing trash disposal services, or utilization of County equipment in support of Permittee activities. Actual costs to County for labor and materials shall be charged. Equipment rental rates shall be charged at currently established Department of Public Works rates.

#### 3. Cash Bond:

If anticipated percentage of gross receipts due the County from the Special Event exceed \$2,000, Permittee may be required to deposit a cash bond with the County for an amount equal to 50 percent of said amount, or as specified in the special event agreement.


#### THE MONTEREY COUNTY BOARD OF SUPERVISORS FINDS:

- A. Section 1.40.010 of Chapter 1.40 of Monterey County Code provides that all fees, penalties, refunds, reimbursements and charges of any kind by the County may be specified in the Monterey County Master Fee Resolution.
- B. The County of Monterey Resource Management Agency (RMA-Parks) is proposing fee adjustments and the establishment of new fees to Article V of the Monterey County Fee Resolution for park use, special events, and rentals which are appropriate to specify in the Monterey County Master Fee. The proposed fees more closely reflect, while still not exceeding, the actual and reasonable costs of services and benefits provided to the public by County parks. In addition to these adjustments, and to more accurately capture the fees associated with services provided, the Article V Master Fee Schedule has been reformatted to make Article V easier to navigate, consolidate the same fees associated with multiple parks, and provide flexibility for adding new park/open space lands.
- C. Any and all adjustments to fees for services reflect no more than the actual and reasonable cost of the service or benefit received by the payor and burdened on the County, and arise from the use of County Park property. Any discount applicable to these surcharges have a de minimus impact on the departmental budget and implementation of that discount does not result in increased fees or costs for other patrons.
- D. By definition, these user fees are not a 'tax' and are exempt from voter approval pursuant to Article XIIIC, section 1(e), subpars. 1, 2, 3, 4, and 5 of the California Constitution (charges arising from benefit received by payor, burden on government to provide services, administrative enforcement, use/admission costs to enter/use government property, and/or enforcement penalties).
- E. This action to modify fees and other charges to meet operational expenses is statutorily exempt from environmental review [Pub. Res. Code § 21080(b)(8)].
- F. Said amendments to Article V shall take effect no sooner than 30 days following final action on the adoption of the amendments.

#### NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors does hereby find:

I. The foregoing recitals are true and correct. II. Article V of the Monterey County Master Fee Resolution is amended, and the fees of RMA-Parks set forth in the attached Article V hereto are hereby adopted. III. 

- Analyzed budget revenues and available count data
  - 67% of Parks Operations revenues are General Fund contributions
- Analyzed fees charged in comparable jurisdictions
  - Counties of SLO, Santa Cruz, and Santa Clara, City of Monterey,
     National Parks, State Parks, Private Campgrounds

#### Current

- Last update November 2014.

- Increased cost recovery and reduced reliance on General Fund.
- Simplified, understandable fee categories reduce potential for errors when assessing fees.

#### Recommendation

Adopt a Resolution to amend Article V of the Monterey County Fee Master Resolution effective September 1, 2018, to adjust and establish new fees relating to Parks user fees pursuant to the attached Article V.
