AMENDMENT No. 1 To Countywide Service Agreement

This AMENDMENT is made to the AGREEMENT for the provision of HVAC Repair Services (RFP #10487) by and between Acco Engineered Systems, Inc., hereinafter referred to as "CONTRACTOR", and the COUNTY OF MONTEREY, a political subdivision of the State of California, hereinafter referred to as "COUNTY".

WHEREAS, the COUNTY and CONTRACTOR entered into an AGREEMENT on October 20, 2015; and

WHEREAS, the AGREEMENT had a three-year term ending on August 31, 2018; and

WHEREAS, as part of the original approval, the Board of Supervisors authorized the Contracts/Purchasing Officer to extend the term of the AGREEMENT by means of up to two (2) extensions of one (1) year periods; and

WHEREAS, the COUNTY and CONTRACTOR wish to amend the AGREEMENT to reflect the COUNTY'S exercise of the option to extend the agreement through August 31, 2019; and

NOW THEREFORE, the County and CONTRACTOR hereby agree to amend the AGREEMENT in the following manner:

- 1. Section 3.1, "TERM OF AGREEMENT", shall be amended by removing "The initial term shall commence with the signing of the AGREEMENT through and including August 31, 2018, with the option to extend the AGREEMENT for two (2) additional one (1) year periods." and replacing it with "The term shall commence with the signing of the AGREEMENT and shall run through and including August 31, 2019, with the option to extend the AGREEMENT for one (1) additional one (1) year period."
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this AMENDMENT and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. A copy of the AMENDMENT shall be attached to the original AGREEMENT dated October 20, 2015.
