

**AMENDMENT NO. 2
TO SERVICES AGREEMENT
BETWEEN AUTOMATIC DOOR SYSTEMS, INC. AND
NATIVIDAD MEDICAL CENTER
FOR
MAINTENANCE AND REPAIR SERVICES OF AUTOMATIC DOORS**

This Amendment No. 2 to the Services Agreement ("Agreement") which was effective on January 1, 2014 is entered into by and between the County of Monterey (hereinafter "COUNTY"), on behalf of Natividad Medical Center (hereinafter "NMC"), and Automatic Door Systems, Inc. (hereinafter "CONTRACTOR"). Collectively, COUNTY, NMC and CONTRACTOR are referred to as the "Parties", with respect to the following:

RECITALS

WHEREAS, the County of Monterey on behalf of Natividad Medical Center and Automatic Door Systems, Inc. entered into an Agreement for maintenance and repair services of automatic doors at Natividad with a term January 1, 2014 through June 30, 2017 and a total Agreement amount not to exceed \$90,000; and

WHEREAS, the Parties amended the Agreement on January 12, 2017 via Amendment No. 1 to extend the term for an additional eighteen month period through December 31, 2018 for a revised full Agreement term of January 1, 2014 through December 31, 2018 and to add an additional \$110,000, thereby increasing the total Agreement amount to \$200,000; and

WHEREAS, the Parties currently wish to amend the Agreement to extend the term for an additional one (1) year period through December 31, 2019 to allow for services to continue for a revised full Agreement term of January 1, 2014 through December 31, 2019 and with an increase of \$40,000 for a revised total Agreement amount not to exceed \$240,000.

AGREEMENT

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

The Agreement is hereby renewed on the terms and conditions as set forth in the original Agreement and in Amendment No. 1 incorporated herein by this reference, except as specifically set forth below.

1. **Paragraph titled, "PAYMENTS BY NMC" shall be amended by removing:**

"NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A-1 as attached hereto this Amendment No. 1, subject to the limitations set forth in this Agreement. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$200,000."

and replacing it with:

"NMC shall pay the CONTRACTOR in accordance with the payment provisions set forth in Exhibit A-1 as attached hereto this Amendment No. 1, subject to the limitations set forth in this Agreement. The total amount payable by NMC to CONTRACTOR under this Agreement shall not exceed the sum of \$240,000."

2. *The first sentence of Paragraph titled, "TERM OF AGREEMENT" shall be amended by removing:*
"The term of this Agreement is from January 1, 2014 through December 31, 2018 unless sooner terminated pursuant to the terms of this Agreement."
and replacing it with:
"The term of this Agreement is from January 1, 2014 through December 31, 2019 unless sooner terminated pursuant to the terms of this Agreement."
3. Except as provided herein, all remaining terms, conditions and provisions of the original Agreement are unchanged and unaffected by this Amendment No. 2 and shall continue in full force and effect as set forth in the original Agreement and in Amendment No. 1.
4. A copy of this Amendment No. 2 shall be attached to the original Agreement.
5. This Amendment No. 2 shall be effective when signed by both Parties.
