40 years of dedicated public service with Monterey County.....)

WHEREAS, Julie Aguero began her career with the County in 1978 as a Typist Clerk I for Elections manually stuffing ballots for a week, transferred to the Assessor's Office to process Homeowner Exemption claims, lost her position due to Proposition 13, and was re-hired as an Account Clerk for the Personal Property section; and

WHEREAS, Julie Aguero promoted to Senior Account Clerk by Public Guardian in 1984 to serve clients, then accepted a lateral transfer to the Auditor-Controller's Office maintaining Schools' accounts and back up to the Welfare Window; and

WHEREAS, Julie Aguero was promoted in 1987 to Accounting Technician for the Property Tax section handling roll changes, direct assessments, refunds and taxpayer inquiries, and assisted in the conversion to Megabyte Property Tax System in 1991; and

WHEREAS, Julie Aguero promoted up the ranks, beginning in 1995 to Senior Accountant Auditor, 2001 promoted to Finance Manager I, served as Secretary for the Property Tax Managers' Subcommittee of the California State Association of County Auditors for two years, subsequently reclassified to Auditor-Controller Analyst II in 2009; and

WHEREAS, Julie Aguero has served as an invaluable asset and member of the Auditor-Controller's Office since 1985 ensuring the County remain in compliance with complicated and ever changing Property Tax related policies over the years to include: AB1290 (1996) Pass-Throughs for Redevelopment projects, SB1096 (2004) Triple Flip legislation for In-Lieu sales tax to pay State Economic Recovery Bonds: In-Lieu Vehicle License Fee (VLF); and implementation of ERAF III, AB2670 (2007) Treating railroad properties as unitary, AB1389 (FY2008-09 and 2009-10) Pass through reporting to the State, Prop 1A Suspension (2009) Loan of property tax revenues from local agencies to State and ERAF IV, and ABX1 26 (2011) Dissolution of Redevelopment Agencies; and

NOW, THEREFORE, BE IT RESOLVED THAT, the Board of Supervisors of Monterey County, on behalf of the County and all citizens thereof, hereby acknowledges, commends, and thanks **Julie Aguero** for her 40 years of exemplary public service to the citizens and residents of Monterey County.
