WHEREAS, Sergeant Michael Burns has served as a Correctional Deputy, Patrol Deputy, Coroner Investigator, Narcotics Detective, Patrol Sergeant, Internal Affairs Sergeant and he served on the Monterey County Sheriff's Office Deputies Benefit Association Board (DBA) for several years, completing his time on the Board as DBA President; and

WHEREAS, Sergeant Michael Burns was promoted to Sergeant on October 1, 2005, and retires as a Sergeant assigned to the Enforcement Operations Bureau Coastal Patrol Station; and

WHEREAS, Sergeant Michael Burns served three years as the Administrative Supervisor for the Search and Rescue Team and he was influential in the implementation of the Project Lifesaver System. Sgt. Burns currently serves as the President of the Monterey County Sheriff's Office Memorial Foundation and was instrumental in the planning and construction of the Sheriff's Office Memorial Wall honoring the fallen Monterey County Deputy Sheriffs; and

WHEREAS, Sergeant Michael Burns received an Award of Merit in June 2004 from the Monterey County Peace Officers Association for his excellent work ethic and dedication while participating in the Narcotics Task Force, NEUCOM; and
