Enclosed herewith is the petition required by the California Streets and Highways Code to formally initiate proceedings to abandon Pesch Avenue (commonly referred to as "Peach Road") and portions of Canal Street and Pine Avenue (collectively, "Subject Road") as shown on the Clark Colony map and plat surveyed by H.B. Fisher, Licensed Surveyor and filed and recorded in the Office of the Monterey County Recorder in Book 1 of Maps at Page 64 and on the Record of Survey filed for record on October 17, 1962, in the Office of the Monterey County Recorder in Book 6 of Maps at Page 147. The request is made because the Subject Road is excess and is no longer needed for public road purposes.

The landowners ask your Board to initiate proceedings to vacate the Subject Road pursuant to section 8320 of the Streets and Highways Code. The landowners recognize any easement for utilities will not be part of the abandonment action.

Subject Road to be abandoned are further described below:

Said Portion of Pine Avenue, 40 feet in width, beginning at the southwestern corner of Lot 282 heading west approximately 1412.19 feet and terminating at Canal Street, as shown on the Record of Survey filed for record on October 17, 1962, in the Office of the Monterey County Recorder in Book 6 of Maps, at Page 147, attached hereto and incorporated herein as Exhibit "A";

Said Portion of Canal Street, 65 feet in width, beginning at the junction of Canal Street and Pine Avenue heading approximately 1194.76 feet northwest and terminating at Pesch Avenue, as shown on the Record of Survey filed for record on October 17, 1962, in the Office of the Monterey County Recorder in Book 6 of Maps, at Page 147, attached hereto and incorporated herein as Exhibit "A"; and

All of Pesch Avenue, 40 feet in width, from the junction of Canal Street, heading both north and southwest and terminating on private properties as shown on the Clark Colony map and plat surveyed by H.B. Fisher, Licensed Surveyor and filed and recorded in the Office of the Monterey County Recorder in Book 1 of Maps at Page 64, attached hereto and incorporated herein as Exhibit "B".






