#### **Resolution No. 18-406**

Upon motion of Supervisor Salinas, seconded by Supervisor Phillips and carried by those members present, the Board of Supervisors hereby:

Board Order

#### **Clark Colony Road Vacation/Abandonment**

a. Adopted Resolution No. 18-406, pursuant to California Streets and Highways Code Section 8324:
1. Found that abandonment of roads involves existing highways and streets, and minor alterations to land which qualify respectively as Class 1 and Class 4 categorical exemptions under the CEQA Guidelines Sections 15301(c) - existing highways and streets; and 15304 - minor public alterations in the condition of the land, and there are no exceptions under Section 15300.2;

2. Vacate approximately 8.4 miles of public road right-of-way interest over certain Clark Colony roads, namely all of Fir Avenue, Pear Avenue, Pesch Avenue (portions also known as Peach Road), Canal Street, Fifteenth Street, Sixteenth Street and portions of Cedar Avenue, Pine Avenue and Oak Avenue, (said roads being 6.3 miles of public road right-of-way that are privately maintained and are not part of the County Road System, together with an additional 2.07 miles of County maintained roads that are part of the County Road System) subject to the reservation of easements for public utilities within said roads;

3. Found that said Clark Colony roads are unnecessary for present or prospective public use;

4. Found that the vacation of said Clark Colony roads is in the public interest because it furthers public health and safety by:

(1) increasing food safety by limiting potential agricultural field contamination from unauthorized access and activities along said roads, including trespassing and illegal dumping;

(2) reducing illegal poaching occurring in the Arroyo Seco River by controlling access to the river from said roads; and

(3) eliminating a non-standard road intersection at the intersection of Peach Road and Thorne Road.

5. Accepted the Planning Commission resolution dated November 14, 2018 finding General Plan conformity, together with a memorandum from RMA-Planning Services dated November 16, 2018 providing a list of specific General Plan policies that demonstrates such conformity;

6. Found that the County's right-of-way interest of said Clark Colony roads is not useful as a nonmotorized transportation facility, as required by California Streets and Highways Code Section 892.

7. Authorized the removal of said Clark Colony roads from the maintained County Road System, as applicable.

b. Directed the County Surveyor to submit the certified copy of the resolution to the Monterey County Recorder for recordation.

Adopted Resolution No. 18-406, pursuant to California Streets and Highways Code Section 8324: 1. Finding the vacation of roads involves existing highways and streets, and minor )

- alterations to land which qualify respectively as Class 1 and Class 4 categorical exemptions under the CEQA Guidelines Sections 15301(c) existing highways and streets; and 15304 minor public alterations in the condition of the land, and there are no exceptions under Section 15300.2;
- 2. WHEREAS, the Board of Supervisors of the County of Monterey accepted the roads offered for dedication shown on the "Map of the Clark Colony," filed July 19, 1905 in Volume 1 of Cities and Towns, at Page 64; and

WHEREAS, a petition signed by 10 freeholders, in accordance with the requirements of California Streets and Highways Code (SHC) Section 8321, was received requesting the abandonment or vacation of the Peach Road and portions of Canal Street and Pine Avenue as shown on said filed map, and/or later deeded to the County for road purposes; and

WHEREAS, Monterey County Resource Management Agency (RMA) staff has identified additional segments of public road right-of-way that are unnecessary for present or prospective public use, and, pursuant to SHC Section 8320, requests the abandonment or vacation of these road segments, being all of Fir Avenue, Pear Avenue, Fifteenth Street, Sixteenth Street, and portions of Pesch Avenue (portions also known as Peach Road), Canal Street, Cedar Avenue, and Oak Avenue as shown on said filed map; and

WHEREAS, in accordance with SHC Section 8313, the Monterey County Planning Commission considered this vacation on November 14, 2018, pursuant to the procedure prescribed in California Government Code Section 65402, and (1) passed a resolution to report to the Board of Supervisors that this vacation is in conformity with the Monterey County General Plan and the Central Salinas Valley Area Plan, a part of the General Plan, and (2) found that the vacation will not have a significant impact on the environment and is exempt from environmental review in accordance with Section 15301(c) and 15304 of the CEQA Guidelines; and

WHEREAS, RMA-Public Works staff has identified the intersection of Peach Road and Thorne Road as a non-standard road intersection due to its unique horizontal and vertical geometrics, and the vacating of Peach Road, as petitioned, would eliminate the use of this intersection by the general public, thereby increasing public safety; and

WHEREAS, the subject Clark Colony roads are roads serving large agricultural parcels, with many being dead-end privately maintained roads that serve a limited number of parcels and, therefore, are not necessary for current or prospective public use; and

WHEREAS, landowners have complained that public use of these rural agricultural roads has encouraged illegal poaching, trespassing and illegal dumping along the right-of-way and the landowners' private properties; the landowners also desire to limit potential agricultural field contamination due to unauthorized access from said roads; and

WHEREAS, the County right-of-way interest in the subject Clark Colony roads located in the Clark Colony area of unincorporated Monterey County westerly of the City of Greenfield, is not useful as a nonmotorized transportation facility as required by SHC Section 892; and

WHEREAS, properties that currently use the subject Clark Colony roads will not be landlocked or without access pursuant to SHC Section 8353(a) which provides that vacating a street or highway does not extinguish a "private easement of ingress and egress to the lot from or to the street or highway"; and

WHEREAS, the Board of Supervisors is authorized to vacate public streets or roads pursuant to SHC Section 8312.

- 1. Finds that the foregoing recitals are true and correct and so declares and determines.
- 2. Accepts the Planning Commission resolution dated November 14, 2018 containing a report of General Plan conformity and a finding that the proposed road vacation is categorically exempt from environmental review in accordance with Section 15301(c) and 15304 of the CEQA Guidelines.
- 3. Pursuant to the provisions of California Streets and Highways Code Sections 8312 and 8340(a), vacates certain Clark Colony roads, namely all of Fir Avenue, Pear Avenue, Pesch Avenue (portions also known as Peach Road), Canal Street, Fifteenth Street, Sixteenth Street and portions of Cedar Avenue, Pine Avenue and Oak Avenue, excepting and reserving therefrom rights for all public utilities, existing and future, within said roads, as said roads and portions thereof are more particularly described in **Attachment A** and shown on **Attachment B**, which are attached hereto and incorporated herein.
- 4. Directs the County Surveyor to submit a certified copy of the Resolution to the County Recorder for recordation.
- 5. From and after the date that this resolution is recorded in the Office of the County Recorder, the vacated roads shall no longer constitute a public road and, as applicable, shall be removed from the County Road System and deleted from the list of County Maintained Roads.

## **ATTACHMENT A**

Situate in Rancho Arroyo Seco, Monterey County, California, and being portions of that certain "Map of Clark Colony" filed for record July 19, 1905 in Volume 1 of Cities and Towns, at Page 64, Records of Monterey County, and said portions being more particularly described as follows:

#### **SECTION 1**

That portion of **Pine Avenue** lying within the limits of Lots 279, 280, 281 and 282 of said filed map;

That portion of **Canal Street** lying within the limits of Lots 280, 354 and that portion within the limits of Lot 356 lying northwesterly of the southeasterly line of Pine Avenue as shown on said filed map;

That portion of **Pesch Avenue** (commonly known as **Peach Road**) lying within the limits of Lots 280, 281, 337, 338, 339, 340 and 341 of said filed map, together with all that certain strip of land 40 feet wide granted for the purpose of a public highway by deed from Cecil O. Page to the County of Monterey dated March 22, 1921 and recorded May 5, 1921 in Volume 182 of Deeds, at Page 158, Records of Monterey County.

#### **SECTION 2**

#### All of Fir Avenue;

#### All of Pear Avenue;

That portion of **Pesch Avenue** lying within the limits of Lots 342, 343, 344, 345, 346, 347, 348, 349, 350, 351, 352, 353, and 354 of said filed map. This portion of **Pesch Avenue** together with the portion described in Section 1 above, describes all of **Pesch Avenue** (some portions commonly known as **Peach Road**) shown on the aforesaid filed map;

That portion of **Canal Street** lying within Lots 64, 65, 66, 67, 187, 277, 278, 279, 356 lying southeasterly of the southeasterly line of Pine Avenue, 357, 358, 359, 360, 361, 362, 363, 364 and 365 of said filed map, excepting therefrom any portion thereof lying within the limits of Oak Avenue and Elm Avenue (being a road later conveyed to the County of Monterey). This portion of **Canal Street** together with the portion described in Section 1 above describes all of **Canal Street** shown on the aforesaid filed map;

All of Cedar Avenue, excepting therefrom:

- 1) That portion thereof lying within the limits of Thorne Road (being a road later conveyed to the County of Monterey);
- That certain portion previously vacated or abandoned by the County of Monterey by Resolution of the Board of Supervisors of the County of Monterey, dated January 21, 1963 and recorded in Reel 137 of Official Records, at Page 457, Records of Monterey County;
- 3) That certain parcel of land conveyed by Wiley Farms, Inc., et al, to the County of Monterey by deed dated April 23, 1962 and recorded May 16, 1962 in Reel 54 of Official Records, at Page 497, Records of Monterey County;

#### All of Fifteenth Street;


#### All of Sixteenth Street;

All of the unnamed road being a strip of land 0.50 chains (33 feet) wide lying southeasterly of and contiguous to the northwesterly boundary of Lot 356 of said filed map;

All that portion of **Oak Avenue** lying southwesterly of the southwesterly line of Fifteenth Street, excepting therefrom that certain portion previously vacated or abandoned by the County of Monterey by Resolution No. 68-67 of the Board of Supervisors of the County of Monterey, dated March 5, 1968 and recorded in Reel 548 of Official Records, at Page 36, Records of Monterey County.
