Trustee Fernandez said he appreciated having Mr. Vanoli as Superintendent but also recognized Mr. Bangs, Associate Superintendent and Ms. Cline, Executive Director of H.R. for their hard work. Mr. Vanoli has a great support system. The Board and District has a great team leading district. Thanks for all you do.

Information: 5. CAASPP Results Presentation

Dr. Witwer gave a detailed report to the Board on CAASPP results. Dr. Witwer focused on EL subgroups and specifically went into detail on this topic. (See PowerPoint Presentation on the Agenda for November 14, 2018).

Comments:

- President Perez-Aguilera shared her observations and said that in looking at the results, they are based on grade levels but there are two student co-horts for each comparison year. For example, the 6th graders at Frank Ledesma for 2016/17 and 2017/18 are not the same group of students. How are we tracking the progress for each class or group of students? Are they improving or declining? Dr. Witwer said there are different ways of looking at data. We look at grade level and look at the teaching trend. When teachers meet to go over data, they are given the scores from the previous years to track their own students. So, they do both.
- Trustee Massa asked for those groups with huge growths, are we having Distriwide grade level meetings where the one school doing well will have conversations with those that did not to share their teaching strategies?
- Dr. Witwer said that one of Mr. Bangs' goals is to have two Districtwide grade level meetings to share successful teaching strategies. There are some teachers who are being successful but are shy and don't speak up and we want to encourage sharing. PLC does help with that. We want to promote the great teaching skills.
- Trustee Pantoja commented that other then teachers collaborating on Wednesdays and does the district give them strategies to teach the material? Dr. Witwer said we'll have another full Professional Development Day on January 7th where teachers will have an opportunity to select specific trainings. Today they had a meeting with all TOSAS on this and they will monitor collaborative conversations. We are trying to focus on the areas where new teachers need training. Trustee Pantoja asked if new teachers have coaches that can work with them such as Math. Dr. Witwer said yes and that Mr. Bangs brought in Solution Tree to help wit this for the secondary levels and they also have a second training with Gear-Up. We are also trying to find why we are not making gains in Math. A lot of language came into the math with CAASPP. Now it is more about problems solving than adding numbers. Trustee Pantoja asked how teachers feel about these programs. What is the feedback? Dr. Witwer said that the feedback for math is that they need supplemental materials. We are looking at what materials work best for them? It's more about teaching strategies rather than materials.

- Trustee Massa asked how many years we've been doing CAASPP? Dr. Witwer said it's been 3 years. She also mentioned that Mr. Bangs, herself and Mrs. Morones had attended a CAASPP training and the testing is dependent on technology. We keep working with that and making sure students feel comfortable with technology.
- President Perez-Aguilera asked if they were keeping track of what PD each teacher is taking and how are they being measured on the trainings they are taking. Mr. Bangs said they had contracted with Frontline to track PD. We will be able to track who has done what. President Perez-Aguilera said that if a class is not doing well, are they able to track what type of training the teacher has had. Mr. Bangs said that would need to be built into the tool kit. They are also working with the TOSAS to provide opportunities for training for teachers.
- Trustee Galvan asked if teachers/staff who receives specific training, do they come back and train other teachers. Mr. Bangs said that was the intent. PD is effective when there is follow-up and is it taking hold or not; do we need to provide support.
- Trustee Galvan would like to see for example, 3rd grade teachers districtwide, teaching the students the same thing at the same time.
- Mr. Vanoli said we are building teacher capacity, meaning they become the experts and with PLCS, Solution Tree training, PBIS for example; we'll get to a point. Also having coaches to support our teachers. We have to try to get tighter alignment between the taught, written and tested curriculum. We are in different place in education now. We have essential standards, we need to share with each other and how are we going to teach it, and how are we going to assess it. The context of how we assess is very important. As far as scores, when you start to look subgroups, these are smaller number of students (representative of that smaller group). We have fewer English Learners and that is because we pre-designate students. Math is different today: Statewide we are struggling in Math so it is a state issue. It is about how we listen to teachers and bring experts to explain the sophistication.

Discussion: 6. LCAP Update Report

Mr. Bangs presented a detailed LCAP report to the Board.

President Perez-Aguilera said she appreciated seeing where balances are available and when implementation is complete. She'd like to know what the plan is for the money and can it be moved to areas. Mr. Bangs said that, that will be a staff focus and LCAP Advisory Committee will guide those discussions.

Trustee Pantoja asked about RTI Aides and how do we determine who needs training and how they'll receive it. Mr. Bangs said that at the January PD training, classified staff will be included in those training and both groups may attend same trainings.


