WHEREAS, the County of Monterey through the CAO-Intergovernmental & Legislative Division manages the Monterey County Cannabis Program;

WHEREAS, the County desires to provide enough staffing allocations to further develop the Cannabis Program Compliance Inspection process; and

WHEREAS, this action results in a financial commitment of \$1,004,823 in the adopted FY 2018-19 Budget that is needed to support the services and program operations of eight positions in the Agricultural Commissioner Office, County Administrative Office, District Attorney, Resource

Management Agency, and Health Department, Environmental Health Bureau and related equipment and lab services. The financial commitment includes a fund to be used for Cannabis Enforcement reimbursement as needed.
