Adopt Resolution recognizing **David Chardavoyne** for his years of service ) and leadership of the Monterey County Water Resource Agency.....)

**WHEREAS, David Chardavoyne** has been the Monterey County Water Resources Agency General Manager since 2011 and has stewarded the Agency in an exempliary manner; and

**WHEREAS,** the Monterey County Water Resources Agency manages, protects, stores and conserves water resources in Monterey County for beneficial and environmental use, while minimizing damage from flooding to create a safe and sustainable water supply for present and future generations; and

**WHEREAS, David Chardavoyne** was initially recruited to resolve a three-party contract dispute related to design and construction of a 10,000 acre-ft/year desalination plant and continued on to become General Manager of this state established agency having an annual budget of \$24 million. A key task he undertook as General Manager was the \$78.2 million project to construct a 10-foot diameter tunnel between the two reservoirs; and

WHEREAS, David Chardavoyne's significant results during his tenure at WRA are: An agreement with California-American Water that concluded the Agency's involvement in the Regional Desalination Project; Agreements to distribute Monterey Peninsula Water Supply Project return water to Castroville Community Services District and the Castroville Seawater Intrusion Project; A purchase power agreement with the Northern California Authority Agency for WRA generated power, raising the Agency's revenue from 3.5 cents/kwh to 7.5 cents/kwh; Successful negotiation of the *Amended and Restated Water Recycling Agreement* which included resolution of longstanding disputes over water quantities and paved the way for water to Pure Water Monterey and additional water for CSIP; and Leadership of the effort to refinance Salinas Valley Water Project Bonds for a net present value savings of \$5.1 million; and

**NOW, THEREFORE, BE IT RESOLVED**, that the Monterey County Board of Supervisors, on behalf of the County and all citizens thereof, hereby recognizes and extends its deepest appreciation to **David Chardavoyne** for his many years of public service and commends him for all his accomplishments.
