**WHEREAS**, the County of Monterey has received the request and Resolution from the North Monterey County Unified School District, requesting that the election of governing board members be conducted on the same day as the Statewide General Election; and

**WHEREAS**, California Elections Code sections 1302(b) allow school districts to request consolidation of their elections with the Statewide General Election; and

**WHEREAS**, California Elections Code sections 10404.5 allow school districts to request consolidation of their elections with the Statewide General Election; and

**WHEREAS**, the Monterey County Registrar of Voters has determined that the change will not cause the ballot style, computer capacity, or voter equipment to be exceeded;

**NOW, THEREFORE, BE IT RESOLVED** that the Monterey County Board of Supervisors authorizes the Monterey County Registrar of Voters to move the North Monterey County Unified School District's odd-year elections and consolidate them with the Statewide General Election, and consolidate the district's next election with the November 3, 2020 General Election.
