WHEREAS, the Board of Supervisors of the County of Monterey is the Board of Directors of the Boronda County Sanitation District (BCSD);

WHEREAS, it is the goal of the County to divest its interests in all County municipal (not parks) sanitation and water systems, including BCSD;

WHEREAS, in April 2016, the County issued a Request for Qualifications for Transfer of Ownership and Responsibility for the systems, including the BCSD;

WHEREAS, the County selected two responders to participate in follow-up interviews and preliminary negotiations;

WHEREAS, to facilitate negotiations, staff proposed completing a system condition assessment and valuation for the BCSD sewer system to help define its assets and liabilities to establish value and support a rate study to establish new rates through a Proposition 218 rate increase;

WHEREAS, BCSD has not had a rate increase within the last 30 years, and the completion of this work should be completed despite the disposition of pending negotiations;

WHEREAS, BCSD has insufficient funding available to complete work estimated to cost \$51,750 for a condition assessment, valuation, and rate study, and an operating transfer from Fund 001 Contingencies of \$37,410 and appropriation from Fund 156 Unassigned Fund Balance of \$14,340 are necessary for completion of this work; and

WHEREAS, upon task completion, any unexpended contingency funds shall be transferred back to Fund 001 Contingencies, Appropriation Unit CAO020.

NOW, THEREFORE, BE IT RESOLVED THAT the Monterey County Board of Supervisors, acting as the Board of Directors for the Boronda County Sanitation District, hereby resolves to approve the following:
