WHEREAS, beginning in Fiscal Year 1998-99 septic system maintenance was provided by CSA 66; and

WHEREAS, the maintenance of the septic tanks is an integral part of the overall treatment process and one discharge operator should have total responsibility for the entire wastewater treatment process; and

WHEREAS, Cañada Woods Water Company, a PUC regulated privately owned public utility, has received a Certificate of Public Necessity and Convenience from the California Public Utilities Commission to provide sewer and water service to the Oak Tree Views Subdivision, and is ready, willing and able to perform the maintenance for individual septic systems currently carried out by CSA 66; and

WHEREAS, public convenience and necessity no longer require that extended sewer service be provided by CSA 66;

Thank you for your letter dated May 6, 2004 regarding Canada Woods Water Company's, LLC, intent to assume septic tank maintenance at Monterra Ranch - Oak Tree Views on July 1, 2004. In response to this request, our Department will begin the process to request that the Board of Supervisors terminate extended services for septic tank maintenance provided by CSA 66 to avoid redundant service charges.

Dear Dr. Bauman:

Pursuant to the authority of the California Public Utilities Commission Decision No. 02-04-006, Cañada Woods Water Company shall assume full responsibility for operation and maintenance of the Oak Tree Views inclusionary housing septic tanks and collection system commencing on July 1, 2004. Further, Cañada Woods Company will assume the wastewater responsibilities and obligations for Oak Tree Views as of July 1, 2004, as set forth in Agreement No. A-07513 (Agreement For Property Related Services For Inclusionary Housing) between the County of Monterey and Oak Tree Housing dated September 9, 1997 and as detailed in Section 2. CSA 66 – Responsibility For Maintenance and Repair as set forth in that Agreement.

Accordingly, Cañada Woods Water Company requests that Monterey County commence amendment of the above Agreement to reflect the new provision of wastewater services by the Utility in lieu of the services provided by CSA-66.

Attached hereto as Exhibits "A" and "B" are the tariff sheets for provision of sewer service to the 42 units within the Oak Tree Views subdivision and a breakdown itemizing the cost of each element of provision of such service.
