

The County of Monterey Board of Supervisors Finds:

WHEREAS, California's Governor Edmund G. Brown, Jr. and the members of the California Legislature have recognized the urgent and immediate need for funding at the local level to combat homelessness;

WHEREAS, The Governor and Legislature have provided funding to local governments under the Homeless Emergency Aid Program as part of SB 850 and the 2018-19 Budget Act (Chapter 48, Statutes of 2018);

WHEREAS, The Governor and Legislature require jurisdictions seeking an allocation through the Homeless Emergency Aid Program to declare a Shelter Crisis pursuant to Government Code §8698.2 and the County of Monterey has declared a Shelter Crisis;

WHEREAS, the County of Monterey has developed a homelessness plan and undertaken multiple efforts at the local level to combat homelessness;

WHEREAS, the County of Monterey finds that 419 persons within the unincorporated areas of Monterey County based on the Point In Time Count conducted in 2017 are homeless and living without shelter;

WHEREAS, the County of Monterey finds that a total of 1,361 persons within the City of Salinas and unincorporated areas of Monterey County based on the Point In Time Count conducted in 2017 are homeless and living without shelter;

WHEREAS, the County of Monterey finds that 2,837 persons within all incorporated and unincorporated areas of Monterey County based on the Point In Time Count conducted in 2017 are homeless and living without shelter;

WHEREAS, the County of Monterey finds that the number of homeless is significant, and these persons are without the ability to obtain shelter;

WHEREAS, the County of Monterey finds that the health and safety of unsheltered persons in the unincorporated areas of Monterey County are threatened by a lack of shelter;

WHEREAS, the County of Monterey affirms the County's commitment to combatting homelessness and creating or augmenting a continuum of shelter and service options for those living without shelter in our communities;

NOW, THEREFORE, BE IT RESOLVED BY the Board of Supervisors of the County of Monterey, **CALIFORNIA authorize** staff to submit an application from the County of Monterey to the Homeless Emergency Aid Program (HEAP) program to the construction of a permanent shelter located at 855 East Laurel Drive, Salinas California. The application will be submitted to the Salinas/Monterey and San Benito County Continuum of Care CA-506 (CoC).


