WHEREAS, the Board of Supervisors, acting on behalf of County Service Area 75 - Chualar (CSA 75 - Chualar), has enacted an Ordinance which provides for the collection of sewer service charges by use of a monthly billing system;

WHEREAS, twelve (12) property owners in CSA 75 – Chualar were identified as allowing past due balances totaling \$4,178.19 to accumulate (Exhibit A);

WHEREAS, Ordinance No. 04225, which amends Section 16 of CSA 75 - Chualar Ordinance No. 3920, allows for the collection of delinquent fees and a lien transfer fee as special assessments constituting a lien on the property;

WHEREAS, it is desirable that past due assessments for sanitation service be collected; and that past due assessments for sanitation service be collected; and

WHEREAS, the Board of Supervisors, acting on behalf of CSA 75 - Chualar, conducted a public hearing, heard the report, and considered any property owner protests and objections to the report to satisfy the requirements of Ordinance No. 04225 regarding procedures for collection of delinquent fees.

NOW, THEREFORE, BE IT RESOLVED THAT the Monterey County Board of Supervisors, acting on behalf of CSA 75 - Chualar, hereby resolves to approve the following:

Confirm the report of delinquent fees from twelve (12) parcels totaling \$4,178.19, including late fees, for CSA 75 - Chualar, as identified in "Report of 2018 Delinquent Fees County Service Area No. 75 - Chualar", attached hereto and incorporated by reference as Exhibit A, and

2. Authorize the delinquent fees as set forth in the confirmed "Report of 2018 Delinquent Fees County Service Area No. 75 – Chualar" (Exhibit A) to constitute special assessments against the respective parcels of land to be collected at the same time and in the same manner as ordinary ad valorem property taxes are collected.
