- d. Authorize the Clerk of the Board to file a certified copy of the report with the Auditor-Controller.

WHEREAS, the Board of Supervisors, acting as the Board of Directors of the Pajaro County Sanitation District, has enacted an Ordinance which provides for the collection of sewer service charges by use of a monthly billing system;

WHEREAS, fifty-three (53) property owners in the Pajaro County Sanitation District were identified as allowing past due balances totaling \$28,391.18 to accumulate (Exhibit A);

**WHEREAS**, Ordinance No. 05054 established procedures for the collection of delinquent fees and a lien transfer fee as special assessments constituting a lien on the property;

WHEREAS, it is desirable that past due assessments for sanitation service be collected; and

**WHEREAS**, the Board of Supervisors, acting as the Board of Directors of the Pajaro County Sanitation District, conducted a public hearing, heard the report, and considered any property owner protests and objections to the report to satisfy the requirements of Ordinance No. 05054 regarding procedures for collection of delinquent fees.

**NOW, THEREFORE, BE IT RESOLVED THAT** the Monterey County Board of Supervisors, acting as the Board of Directors of the Pajaro County Sanitation District, hereby resolves to approve the following:

- 1. Confirm the report of delinquent fees from fifty-three (53) parcels totaling \$25,211.18, plus \$3,180 for lien transfer fees, for the Pajaro County Sanitation District, as identified in "Report of 2018 Delinquent Fees Pajaro County Sanitation District", attached hereto and incorporated by reference as Exhibit A; and
- 2. Authorize the delinquent fees as set forth in the confirmed "Report of 2018 Delinquent Fees Pajaro County Sanitation District" (Exhibit A) to constitute special assessments

against the respective parcels of land to be collected at the same time and in the same manner as ordinary ad valorem property taxes are collected.
