01. DECLARATION:

The Monterey County Workforce Development Board, hereinafter called "MCWDB", and the Santa Cruz County Workforce Development Board, hereinafter called "SCWDB", wish to amend their Memorandum of Understanding (MOU) entered into on the 1st day of September 2016, for the purpose of revising the amount of project funds to reflect the decrease in participants enrolled in the Proposition 39 2.0 Pre-Apprenticeship Training Grant from the State of California Workforce Development Board.

02. OPERATIONAL AND FISCAL PROVISIONS:

Page 1, Section 3, "Operational and Fiscal Provisions", under subpart "MCWDB will", is hereby amended to read as follows:

Under item g., remove the amount "\$123,533" and replace it with "\$99,904".

Page 2, Section 3, "Operational and Fiscal Provisions", under subpart "SCWDB will", is hereby amended to read as follows:

Under item b., remove the number "25" and replace it with "17".

Page 2, Section 3, "Operational and Fiscal Provisions", under subpart "Project funds allocated to Santa Cruz County are outlined below", is hereby amended to read as follows:

- For SCWDB Staff Salaries, remove the amount "\$57,887" and replace it with "\$55,204"
- For Staff Travel, remove the amount "\$680" and replace it with "\$500"
- For Tools & Supplies, remove the amount "\$7,500" and replace it with "\$5,100"
- For Supportive Services, remove the amount "\$57,466" and replace it with "\$39,100"
- For Total Santa Cruz Budget, remove the amount "\$123,533" and replace it with "\$99,904"

Subject to the foregoing amendment, all other terms and conditions of the original MOU shall remain in full force and effect.

If there is any conflict or inconsistency between provisions of this amendment and the Original MOU, the provisions of this amendment shall control in all respects.
