WHEREAS, the Department of Social Services has identified one-time savings in the General Assistance budget unit 001-5010-SOC002-8253; and

WHEREAS, increased appropriations of \$20,000 are needed in the Community Programs budget unit 001-5010-SOC004-8258 FY 2018-19 Adopted Budget, to support the shelters increased maintenance costs; and

WHEREAS, appropriations in the General Assistances budget unit 001-5010-SOC002-8253 FY 2018-19 Adopted Budget, and can be decreased by \$20,000 without impacting service delivery; and

NOW, THEREFORE, BE IT RESOLVED, the Board of Supervisors of the County of Monterey hereby:
