WHEREAS, The County of Monterey Capital Improvement Program (CIP) is a five-year plan of the public projects necessary to maintain and improve the public works of Monterey County and the orderly implementation of the County General Plan; and

WHEREAS, The County of Monterey Resource Management Agency (RMA) works with County Departments to update the CIP on a yearly basis to reflect the County's needs, priorities, and available funding; and

WHEREAS, On April 22, 2019 the Budget Committee (BC) supported the approval of the FY 2019-20 capital funding for consideration in the Annual Budget; and

WHEREAS, On May 13, 2019 the Capital Improvement Committee (CIC) supported the approval of the CIP Five-Year Plan FY 2019-20 through 2023-24 and recommended the following unfunded projects as priorities for funding: 1901, PW-18-04, PWF 2019-16, PWF 2019-19, PWF 2019-20, PWF 2019-21 and PD 2017-03, with project 1901 - HVAC & Bio Safety System: 1270 Natividad Rd as the top unfunded priority; and

WHEREAS, On May 29, 2019 the Planning Commission (PC) passed a resolution determining that the CIP conforms to and is consistent with the 2010 Monterey County General Plan, the Local Coastal Program and 1982 General Plan as applicable.

NOW THEREFORE BE IT RESOLVED, by the Monterey County Board of Supervisors that said Board does hereby approve the CIP Five Year Plan FY 2019-20 through FY 2023-24, which includes ninety-one (91) projects fully funded in FY 2019-20, with total costs of \$242 million for FY 2019-20 – FY 2023-24, and sixty-seven (67) projects with unfunded costs for FY 2019-20, including eleven (11) projects partially funded for FY 2019-20, totaling f \$162 million for FY 2019/20 – FY 2023/24.
