Authorize and direct the Auditor-Controller to amend the FY 2018-19 Pajaro County Sanitation District Adopted Budget, Fund 151, Appropriation Unit RMA040, to increase appropriations by \$67,397, financed by an operating transfer from General Fund Contingencies, Fund 001, Appropriation Unit CAO020, of \$67,397 (4/5th vote required); and c. Authorize and direct the Auditor-Controller to transfer \$67,397 from the FY 2018-19 General Fund Contingencies, Fund 001, Appropriation Unit CAO020, as a loan, to be repaid with interest at the County Treasury Investment Pool interest rate, to Pajaro County Sanitation District Fund 151, Appropriation Unit RMA040, where the General Fund has sufficient appropriations available in the adopted budget to fund the transfer (4/5th vote required).

WHEREAS, emergency repairs were required to the Pajaro County Sanitation District (PCSD) Las Lomas Lift Station in November 2018;

WHEREAS, it was necessary to complete these repairs to ensure the proper functioning of the lift station;

WHEREAS, the costs of the Las Lomas Lift Station emergency repairs are anticipated to exceed anticipated revenues by \$67,397 by fiscal year end;

WHEREAS, the FY 2018-19 General Fund Contingencies (001) has been identified as the appropriation source to fund the budget shortfall that resulted from this emergency expenditure;

WHEREAS, this transfer shall be considered as a loan to PCSD Fund 151, Appropriation Unit RMA040, to be repaid with interest at the County Treasury Investment Pool interest rate:

WHEREAS, a claim has been made with the County's property insurance carrier and is pending final review; and

WHEREAS, any insurance reimbursement shall be deposited into the General Fund Contingencies (001) toward repayment of the loan;
