WHEREAS, the Department of Health is seeking to amend the Fiscal Year 2018-19 EMS Operating's adopted budget 001-4000-HEA006-8109 to increase appropriations by \$192,635; and

WHEREAS, for Fiscal Year 2018-19, the budgeted appropriations to provide EMS services were \$154,897 given that all EMS expenditures are covered by the CSA-74 (Fund 092) and Maddy (Fund 016) funds; and

WHEREAS, in Fiscal Year 2018-19, the EMS Agency will receive approximately \$192,635 in unanticipated revenue from penalties assessed to the ambulance provider and a reimbursement for an expenditure representing AMR's share of the cost related to the expansion of the current interoperability capabilities of the County's radio system.
