AMENDMENT NO. 1 TO STUDENT PLACEMENT AGREEMENT BETWEEN COUNTY OF MONTEREY AND BRANDMAN UNIVERSITY

This **AMENDMENT NO. 1** to the County of Monterey Student Placement Agreement (hereinafter referred to as "AGREEMENT"), is entered by and between Brandman University (hereinafter referred to as "INSTITUTION"), and the County of Monterey, a political subdivision of the State of California (hereinafter referred to as "COUNTY").

WHEREAS, the COUNTY entered into an AGREEMENT with INSTITUTION for the term from July 1, 2016 to June 30, 2019 to partner for the placement of students within the Department of Health to complete internship/externship assignments as part of students' field education and service-learning requirements for their respective field of study program; and

WHEREAS, the COUNTY and INSTITUTION hereby wish to amend the AGREEMENT to extend the term for one (1) month for a revised AGREEMENT term from July 1, 2016 to July 31, 2019 for the provision of one (1) student to complete internship assignment.

NOW THEREFORE, the COUNTY and INSTITUTION hereby agree to amend the AGREEMENT in the following manner:

- 1. All references to the AGREEMENT term July 1, 2016 to *June 30, 2019* shall be replaced with July 1, 2016 to *July 31, 2019*.
- 2. Except as provided herein, all remaining terms, conditions and provisions of the AGREEMENT are unchanged and unaffected by this Amendment and shall continue in full force and effect as set forth in the AGREEMENT.
- 3. This Amendment No. 1 shall be effective July 1, 2019.
- 4. A copy of this Amendment shall be attached to the original AGREEMENT executed by the COUNTY on July 26, 2016.
