WHEREAS, George T Riley began his career in local government management before moving to California where he worked twenty-five years in the County of San Mateo as Executive Director of the Human Resources Commission, Executive Assistant to the County Manager, finally retiring after serving fifteen years as the Director of Housing and Community Services; and

WHEREAS, George T Riley retired to Monterey in 1997 where he began his second "career" as a community activist, founding Citizens for Public Water in 2005, then later in 2013, co-founding Public Water Now, and a co-leading 2014's unsuccessful Measure O campaign. Ever the optimist, George T Riley persevered to lead the 2018 Measure J campaign to success ultimately directing the Monterey Peninsula Water Management District to complete a feasibility study on a public buyout of California American Water's Monterey System; and

WHEREAS, **George T Riley** was an intervenor with the California Public Utilities Commission from 2009-2018 and was also a member of the Monterey Peninsula Regional Water Authority's Technical Advisory Committee from 2013 through 2017; and

WHEREAS, **George T Riley** serves on California State University, Monterey Bay's Osher Lifelong Learning Institute Program Committee, the Board of Directors for the League of Women Voters in Monterey County, and actively volunteers his time for the Progressive Democrats for America, the Peace Coalition, the Green Party, and Veterans for Peace; and

WHEREAS, George T Riley was elected in 2018 to the Monterey Peninsula Water Management District where he serves as Chair of the Administrative Committee, on the Water Supply Planning Committee, the Seaside Groundwater Basin Watermaster Board, and alternate on the Monterey County Special Districts' Association; and

WHEREAS, Since 1986 **George T Riley** has written a financial and special interest analysis of state ballot propositions, a progressive viewpoint on propositions, that is circulated widely by friends and colleagues across the state; and
