AMENDMENT NO. 1 TO SERVICES AGREEMENT

BETWEEN HONEYWELL INTERNATIONAL, INC. AND COUNTY OF MONTEREY, ACTING THROUGH ITS INFORMATION TECHNOLOGY DEPARTMENT.

FOR

MAINTENANCE OF HEATING, VENTILATION, AND AIR CONDITIONING SYSTEM

This Amendment No. 1 to the Services Agreement ("Agreement") which was effective on July 1, 2016 is entered into by and between the County of Monterey, acting through its Information Technology Department (hereinafter "COUNTY"), and Honeywell International, Inc. (hereinafter "CONTRACTOR"); (collectively, the County and CONT! ACTOR are referred to as the "Parties"), with respect to the following:

RECITALS

WHEREAS, the Agreement states that CONTRACTOR is to provide maintenance of the heating, ventilation, and air conditioning (HVAC) system at the County of Monterey's Information Technology Department for the term of July 1, 2016 through June 30, 2018, in a total amount not to exceed \$107,568; and

WHEREAS, COUNTY and CONTRACTOR currently wish to amend the Agreement, with prior approval from the Monterey County Board of Supervisors, to extend the agreement by one (1) year for a revised agreement term of July 1, 2016 through June 30, 2019 and add an additional \$45,973.20 for a revised agreement total of \$153,541.20.

NOW, THEREFORE, the Parties agree to amend the Agreement as follows:

- 1. Paragraph 2, titled, "PAYMENT PROVISIONS" shall be amended as follows:

 "County shall pay CONTRACTOR in accordance with the payment provisions set forth in Exhibit A, subject to the limitations set for in this Agreement. The total amount payable by County to CONTRACTOR under this Agreement shall not exceed the sum of \$153,541.20."
- 2. Paragraph 3, titled, "TERM OF AGREEMENT" shall be amended as follows:
 "The term of this Agreement is from July 1, 2016 to June 30, 2019, unless sooner terminated pursuant to the terms of this Agreement. This Agreement is of no force or effect until signed by both CONTRACTOR and County with County signing last, and CONTRACTOR may not commence work before County signs this Agreement."
- 3. Section IV, "Schedule of Rates for Maintenance" in Exhibit A, "Scope of Services/Payment Provisions" shall be deleted in its entirety. The parties agree that County will pay the sum of \$45,973.20 for all work performed during the period of July 1, 2018 through June 30, 2019, excluding only the work specified in Section II, "Scope of Services," subsection g. Payment for the services specified in Section II, "Scope of Services," subsection g shall be billed to the County at the rate of \$191.22 per hour, as needed, subject to prior approval by County.

- 4. Section IV, "Term of the Agreement" in Exhibit A, "Scope of Services/Payment Provisions," shall be amended as follows: "The term of this Agreement shall be from July 1, 2016 through June 30, 2019, unless sooner terminated pursuant to the terms of this Agreement."
- 5. Section VI, subsection c, "Payment Provisions," in Exhibit A, Scope of Services/Payment Provisions" shall be amended by adding the following line item to the table set forth therein: "July 1, 2018 through June 30, 2019, Recurring Quarterly Maintenance, \$45,973.20;" and changing the following line item in the table as follows: "July 1, 2016 through June 30, 2019, Reserve for Billable Labor, \$20,000.00;" and by changing the total in the table as follows: "Total: \$153,541.20."
- 6. Exhibit B to the Agreement, titled, "List of Covered Equipment" shall be deleted and the following table substituted, as follows:
