6. Board Comments

Supervisor Chris Lopez shared Happy Lunar New Year; it's the Year of the Pig and he hoped it will be a good one.

Supervisor Mary L. Adams commented on the meeting conducted last week where they responded to numerous constituents concerns; she hosted a community meeting on getting better prepared for the next wildfire, more than 300 people attended which was hosted at the new Monterey Peninsula Regional Park District headquarters the former Rancho Canada Golf Course; she thanked General Manager of the Monterey Peninsula Regional Park District Rafael Payan for helping pull it together but she really wanted to give a special thanks to the number for people who were there: Gerry Malais, from County OES, Chief Katys from Monterey Regional Fire, Jonathan Pangburn from Cal Fire, Under Sheriff John Mineau who all did an excellent presentation; she specifically wanted to thank County Administrative Officer Dr. Bauman who attended and was able to respond to questions that came up from the audience on the County's role in preparing for the next fire; they also had representation from numerous other agencies to help answer questions like the City of Monterey, Caltrans, Big Sur Fire Brigade, State Parks, Highway Patrol Presidio, SPCA and so many others who will play a part in what will have to be done when they respond to the next emergency fire; there were resource tables around the room so people could take away information and have the opportunity to speak one-on-one to the various representatives; the week before that there was a meeting she participated in which was an evacuation summit hosted by the City of Monterey with a variety of different fire and police representatives from Monterey Peninsula; she commented all of the speaks to the tragedies that we had in Santa Rosa and Paradise and shows that the issue of wildfires is at the forefront of people's mind; she stated, you think it will flood outside but we know that it's not if it's when the next big fires are going to happen; she said that during the question-and-answer part of the meeting members of the public raised several questions about maintaining defensible space around their homes and one of the outcomes she had during the meeting was the opportunity to talk with Carl Holm, Director of the County's Resource Management Agency Department from this she will bring back a board referral to have a presentation on both the state's laws and the county's ordinances and regulations on permitting requirements that may impede a property owners ability to manage vegetation for fire protection; she looks forward to working with Cal OES and Monterey County OES' staff that will be doing a year-round evacuation planning program and hopes that we can take that effort and include it in the public meeting and outreach as it is absolutely clear that so many people in the unincorporated area have legitimate concerns about their safety when it comes to fire; from her comments she provided a real broad update to the audience and also shared that this was live streamed on the Cal Fire website and it may also be shown on AMP as it was filmed; three hundred people attended and it was an amazing; secondly she commented that this week is the Pebble Beach AT&T golf tournament so traffic's going to be here as well as many golfers and a couple days of sunshine.

Supervisor John M. Phillips commented on a peace march on Sunday, in his district, which Supervisor Luis A. Alejo set up and will comment on.

Supervisor Luis A. Alejo acknowledged all the artists that were honored last Saturday night at the arts gala for the Arts Council for Monterey County which was a really successful event; there were some pretty amazing artist that were recognized; he also mentioned that this Sunday is the 25th anniversary of the tragic death of two young people in Monterey County that were residents of

Pajaro, at the time, Jessica Cortez was only 9 years old, her brother was 16 and their mother had sent them down the street to the bakery when they were gunned down by individuals who are never brought to justice; this was a tragic case because their mother Maria Salazar Cortez two years prior to that had lost her sixteen-year-old daughter in a car accident and then two years later she loses two other children so you can imagine a mother losing three of her five children in a span of two to three years; she has suffered a lot throughout her life and he had the opportunity to sit down with her and have an hour long conversation just catching up on what's happened over the last 25 years; in memory of her children a march that started 25 years ago, by young people, in his hometown in their memory has continued every year and it is led by mothers and family members of numerous and dozens of other families who lost their loved ones to domestic violence or gang violence in the community; this Sunday starting at 11 a.m., on the plaza, they will march into Pajaro where he and Supervisor Phillips are going to build a memorial bench with funds raised from private dollars; the bench will have a plaque in their honor; also this small park which is off Salinas Road, will be renamed the Cortez Park and a memorial Japanese cherry blossom tree will be planted; this is one example where the community hasn't forgotten the names of young people that they're not just statistics, they are brothers and sisters that were not forgotten, their names or ages or faces and he's proud that the community has continued to come over to march every year to educate people about the impact of violence on families because the pain never goes away; he shared that today Jessica would be 34 years old and her brother would be at 41 and he wondered what they'd be doing today, would they be teachers, business leaders, educators you have to wonder what they would have become had their lives not been cut so short; he was nineteen, at the time, when it all happened; the community is invited to join the event in memory of these kids, their families and he hopes that this will continue; lastly he commented that as a result a lot of issues with gang violence around that time is now at a 30-year low in crime and that the Community of Watsonville has the lowest per-capita crime in Santa Cruz County; he went on to say that sometimes these efforts do make a difference and despite it being a working-class area which is highly immigrants and highly a Latino community they were still able to make some strides in turn to bring peace to neighborhoods.

Supervisor Jane Parker commented on some of the events that were announced by Mel and Regina Mason; she reiterated that Mel mentioned on February 16th at 2:00 p.m. the film on black psychology and then on March 1st from 6:00 to 8:00 p.m., at the village project, the archaeologists Mr. Browder which all sound like really interesting events; these were just some of the Black History Month events happening in her district; there are ones that are happening all over the county, there's the Seaside Black History Month art reception and program at Seaside City Hall on Sunday the 17th of February from 1:30 to 3:30 p.m.; she mentioned that our Civil Rights Office was working on some Black History Month's events, their theme this year is African American migration and so far they have an interview with Helen Rucker talking about her journey where she grew up on then coming to this area; there will be a message going out to County employees and on the Civil Rights Office's web page with links to other events that are going on within the county family; out in the community and anyone's interested, there is a very good resource on the Cal State Monterey Bay website that talks about some of these events in black history month, on the 10th of February, Sunday from 6:00 to 10:00 p.m. there is gala, all black gala, lessons from Ferguson, there's a film

on Martin Luther King called King a filmed record from Montgomery to Memphis that's on Tuesday the 19th of February at 7 p.m. that's at the Peace and Justice Center there's also the NAACP and CSUMB are having a they often meet jointly particularly in the black history month so this is their eighth year of doing that that's on Thursday February 28th from 7:00 to 8:30 p.m. that's at the University Center, Living Room at CSUMB then there's a tour of historically black churches that is going on throughout February and into March as well and there is information about carpooling and location details on that CSUMB website and then another interesting series Harambee African American Heritage men's support group that's a Monday evenings from 3:30 to 5:00 p.m. through February and March and April again information on CSUMB website again NAACP and CSUMB jointly sponsored series on anti-complacency bi-weekly club meetings on Wednesday at 6:00 p.m. at the Student Center on CSUMB so it's a lot going on to help us honor and celebrate Black History Month and she courage's anyone, who is able, to get to some events; she also mentioned hot topics as it's a new year and her monthly gathering to connect with community members will be happening as usual; they have some new location this year; the next meeting is February 11th that's next Monday in Marina at Cheesecake Dreamations and then the following month they will be in Salinas at the Pizza Factory and then after that they'll be back in Seaside at the Oven Pizzeria all start at 5:30 p.m. on the second Monday of the month where they go over the agenda for the Board of Supervisors' meeting and then any other topics that the attendees want to discuss; then just a reminder about the town hall next Wednesday, not this week, but next week February 13th this is being put on by council members John Wizard and Dave Pacheco at the Oldemeyer Center in Seaside from 6:00 to 8:00 p.m. to discuss peninsula homeless shelter sites so that should be a good discussion and she again encourages anyone, who is interested, to participate.
