Supervisor John M. Phillips made no comments this week.

Supervisor Chris Lopez commented on a wonderful meeting down in Lockwood at the community center with about 80 folks who turned out to talk about the lake operations; he wanted to let his colleagues and the public know that they have a lot of optimism about the future of the lake and the facilities that are for Monterey County and the people of South County; they had a good show up from a group of equestrians folks from throughout the State of California who are quite passionate about our parks so it's great to see that momentum.

Supervisor Mary L. Adams commented she was really pleased the Chair of the Parks Commission, Joe Hartline, was able to come down from Carmel Valley to attend the meeting Supervisor Lopez mentioned and she shared he was really delighted to be able to be there; also she wanted to publicly acknowledge her appreciation for RMA, particularly the Public Works staff, for their support of last week's, Carmel Valley Road Advisory Committee meeting; it was a terrific turnout and she thanked them for the quick response to the various road hazards that they have been having caused by the storm particularly in the Tashara and Jamesburg areas; she thanked the RMA Planning staff as well as the Cannabis Committee for moving forward with the outdoor grow pilot program they worked so hard to develop; she was happy they're moving forward with this and thought that a real problem was created economically for the people who have been legally growing cannabis in the community when we passed the original ordinance; she was really thankful the committee is taking a look at this and hopes they will continue to support the staff to meet the June 30th deadline that is related to the CEQA exemption for ordinance development.

Supervisor Luis A. Alejo announced the U.S. Census is now hiring and recruiting local residents to work on the upcoming census and their website is 2020census.gov/jobs; he wanted to encourage as many of the local resident and community as well to apply and get into the recruitment process to benefit from those jobs that pay a decent salary; also he mentioned that Supervisors Lopez, Adams and he are headed to the National Association of Supervisors conference for legislative Summit at the Capital starting this weekend where they will be visiting with our local Congressional Representatives and talking about the priorities our County has there and they will all be representing our County at that conference; lastly he praised the RMA staff and thanked Brett and all the Park staff that were trying to install a memorial bench in Pajaro as they had a lot of challenges with a lot of bad weather and a lot of rain, half the bench got separated through FedEx but at the end of the day staff really came through and he presented them with Certificates of Recognition and he wanted to give them a personal shout out for their professionalism in trying to achieve those goals that are important to those families who lost loved ones to gang violence.

Supervisor JaneParker commented she attended a business opening not this weekend but the one before for a a barber shop in Seaside called Side Effects that is being put together by three local young men on the part of a Broadway Obama Way that had recently been reconfigured to be more pedestrian-friendlier; it's where the Farmers Market happens and the whole idea behind making those sort of physical exterior changes is to have it be more of the gathering place; there is nothing better for an area like that than a barber shop which is a real hub of community so it was really great to see these young men who have grown up in the community wanting to establish a business that is going to continue to do so much, and it's going to help with that revitalization of that segment of Broadway; she shared it's a real challenge for communities like Seaside and Marina that haven't had a traditional downtown and they're working to establish that and so having a business like that open she thinks will be valuable and it was really great for her to be there and also neat to see those young people with their endeavor that will add so much.
