**Board Comments** 

Supervisor John M. Phillips is absent for board comments this week.

Supervisor Jane Parker shared the My Town pop up children's museum is open for families to grow and play together this summer at the CSUMB Salinas City Center otherwise known as the Steinbeck Center. It's a partnership between My Museum, CSUMB, the Transportation Agency for Monterey County, Hijos Del Sol Arts, Salinas public library and First Five of Monterey County. It's a pop-up children's exhibit that's called My Town, it's fun, it's a hands-on exhibit and it educates children about the community they live in. The exhibit will continue through July 21st so another several weeks. It's free and it's open to the public. It welcomes students from all ages with an accompanying adult and it's open certain days of the week so Thursdays from 10:00 a.m. in the morning until 7:00 p.m. in the evening, Fridays and Saturdays 10:00 a.m. to 5:00 p.m. and on Sundays from 11:: a.m. to 5:00 p.m. check it out it's open this week and through July 21st.

Supervisor Luis A. Alejo commented on the big event taking place here to Monterey County this week so he wanted to take the opportunity, on behalf of the Board of Supervisors, to welcome our guests and visitors who are attending the U.S. Open. He thinks they are expecting over 250,000 people to attend the Monterey Bay so it's always good when local government recognizes what a big event this is. Not only some of the biggest players in golf throughout the world are right here in our own backyard. It's a big economic benefit for the tourism industry for hotels and restaurants. There is a significant increase in traffic but we ask our local residents to be patient as these events are important for our economy and certainly for local jobs that we are grateful for. He also wanted to mentioned that they did have their tabling for their mobile office hours last Friday at the Latino Farmers Market at the rodeo grounds. It's a way to get out of office and try to go to where the people are and to be more accessible without needing an appointment. Lastly, he recognized all of labor unions that are celebrating their annual awards dinner this Friday in Monterey and wanted to congratulate and salute all those hard-working people that are the backbone of our economy.

Supervisor Mary L. Adams commented it looks like District 1 took all the thrill of the Fifth District which is the U.S. Open. Thank you Supervisor Alejo for commenting on it. It really is a big event and she speaks to the visitors in the hopes that they enjoy their time here but more importantly she speaks to all of the residents. They have a lot of information on their District 5 website to talk about the traffic issues and when the best times are to come and go. One of the problems she knows people are facing are their commute times into work. She is hopeful that people will remain patient and ensure that they acknowledge the fact that it is going to be a little bit tough and 250,000 is alot of people. Most of them will be concentrated in the Fifth District and also on Highway 1 and Highway 68. Please do remain calm and if you have any issues don't hesitate to call the district office. They will try to give you as much information as they possible can to make it easier on you but the result will be very positive. It really does bring in millions and millions and millions of dollars to the community and the County and provides a whole lot of extra jobs for people that will benefit all all the families who live locally.

Supervisor Chris Lopez shared last week they held a great town hall down in South Monterey County out on Old Stage Road to discuss traffic improvements on 101. It was very well attended, Supervisor Parker had a staff member there and they had about fifty (50) members of the community come out and share thoughts about improvements along the 101 corridor between Chualar and Salinas with those agracrossing creating concerns about safety. From this they had some thoughts that are going to be brought forward through TAMC through a study over the next year hopefully to address some of those concerns. His second comment is that it's hot. As we experience this weather that is quite abnormal for this time of the year he encourages every Monterey County resident to check on your vulnerable neighbors and make sure that everybody in your neighborhood is hydrated and staying cool because it can impact the vunerable populations, the young children and especially older adults. Please check in on your neighbors. He knows as he is checking in on folks making sure that their AC is working because in some parts of South County folks are still pretty confident that they don't need AC please stay aware and do everything you can to keep folks in your neighborhood safe.
