Supervisor Jane Parker this Saturday is the Monterey Peninsula Pride Celebration and Parade starting at 11:00 a.m. there will be a parade through

downtown Monterey and then a celebration at custom house Plaza starting at 12:30 p.m. so everyone is welcome.

Supervisor Luis A. Alejo commented it is good to be back as he was gone last week to his first trip to Europe. He was there for the running of the bulls and he brought all his colleagues a banuelo or a handkerchief officially from Pampiona. He was lucky not to get gored or stomped on by the bulls. Speaking of the bulls he wanted to announce and welcome everyone for Big Week, the California Salinas Rodeo officially starts tonight with banda night, tomorrow PBR and a lot of other events throughout the week and it's something he thinks that all the residents of Monterey County and surrounding communities really appreciate. He wanted to wish this year rodeo a very successful one. Last Sunday he participated in Chevrons' Soccer Academy held at CSU Monterey Bay. This is the first year it has taken place here in Monterey County which is a free soccer academy for the youth of our community. They hope to continue the academy with every year but during Sunday's festivities they also contributed \$50,000 towards our Salinas regional soccer complex and he wanted to thank Chevron for that support. They also indicated they might try to provide additional support next year to get phase two (2) off the ground. Again, thank you Chevron for being a partner with us in that effort. Lastly, he took a few moments to say a few words that last Sunday they also had a immigrant rights, know your rights, forum in East Salinas and he wanted to take opportunity to express and denounce the threatened raids against immigrant families. Monterey County our county has the highest percentage of non-citizens out of any county in California so there's obviously a lot of fear, anxiety, frustration about what this means to local communities. He was thankful for the Alisal Union School District, the Alisal Family Resource Center and other community organizations that came to go to begin educating and reminding people about their rights in case ice agents end up into the front door. He also wanted to encourage people to look for these cards around the community. There is a number to call if people do see raids or immigration enforcement taking place that number is 831-643-5225 which is the rapid response number that if there's anything taking place in our community a wide network of immigration lawyers and community organizations would be alerted to what is happening. If you do see something happening, you are lawfully allowed to to record or take photos from a short distance and that way we can verify what is happening and shed light on how these raids are impacting local families. There is nothing more powerful than to publicize how this tears communities apart. He wanted to encourage people to be alert and know they are not alone. That we are here with you and that are County agencies will not be participating in Immigration raids or enforcement. This is not our role that is the jurisdiction of the federal government but he wanted to reassure that we are here with you and that we we worry for you but we will do everything possible to defend you as well. Our state leaders are on the same page as he is.
