# MOBILE SHOWER FACILITIES FOR SALINAS WARMING SHELTER

**OCTOBER 8, 2019** 



## Background

- Warming Shelter (111 W Alisal)
  - Remodeled modular from offices (December 2017)
  - Scheduled to operate through April 2021
- Demand exceeds supply for public showers in the vicinity of downtown Salinas
- Timing favors pre-fab vs ground-up construction (18 months)



## Access to Hygiene/Shower Facilities



Access to adequate sanitation infrastructure, including toilets, showers and hand washing facilities, has long been identified as a precursor for personal hygiene and good health.



Persons experiencing extreme poverty, especially those experiencing homelessness, may face reduced access to sanitation facilities and difficulties engaging in health-promoting self-care activities as a result.



The current Salinas warming shelter has been at capacity since opening in winter 2017. Usage reports indicate that 1/3 of the shelter residents are children – many who are school aged.



Current facility does not currently provide shower facilities.
Toilets and hand washing sinks only



Within the nearby vicinity, only 2 showers are open to the public at the Dorothy's Place Drop-In Center. Other facilities require program participation or fees.



#### **Proposed Plan**

- Purchase a 6-unit trailer
  - Combine shower and toilet room in each unit.
  - ADA compliant.
- Park trailer in space outside the warming shelter
  - No new impact to parking
- Expand scope of work for current provider (Community Homeless Solutions) to add management of the Shower Access for SHELTER GUESTS to include
  - Scheduling access
  - Security and oversight
  - Cleaning
  - Towel service & laundry
- Shelter Guest Use Hours: 4PM 8PM every day
- Estimated Delivery December 2019
- Estimated Opening January 2020

### Recommendations

- Add the 111 West Alisal-Furnish and Install Portable Restrooms/Showers Project FY 2019/2020 Capital Project List
- Approve purchase and installation of a 6-unit shower facility to use at 111 W Alisal until the permanent facility is completed at 855 East Laurel
- Funding for Capital Project Phase
  - Authorize \$173,431
  - Up to \$117,000 from Health Department's Whole Person Care Program
  - \$56,431 requested from General Fund Contingencies to fund the shortfall
- Funding for Services
  - Department of Social Services Community Programs Budget will support the estimated FY 2019/2020 cost of \$124,500
  - Future request from Social Services for estimated FY2020/2021 costs of \$214,000
