



The participants were treated at the DRC between January 2017 and February 2019




## Intermediate Outcomes Program Completions

#### DISCHARGE RESULTS

The Monterey DRC had 128 total program discharges. Discharges are classified by three categories:

- Positive: includes Successful and Completion discharges
- Neutral: includes Agency Ordered Terminations, External Transfers, and any participant deaths
- Unsuccessful: includes Absconds, Jail Termination and Unsuccessful discharges




This data reflects July 1, 2018 through June 30, 2019 discharges.



## **Intermediate Outcomes Education/Employment**

#### EMPLOYMENT RESULTS

A goal of the DRC is to assist participants with securing employment and enrollment in school. The graph below shows the average participants employed and/or enrolled in school by quarter.




This data does not include Aftercare. 100% of these participants are employed or enrolled in school. The data reflects July 1, 2018 through June 30,2019.



## Intermediate Outcomes Sobriety Rates

#### DRUG TESTING RESULTS

Each DRC participant is required to test weekly for illicit substances. Below is the percentage of participants who tested clean during the reporting period (no drops and no shows are both considered as "positive" tests).
