WHEREAS, Nat Anthony Agliano was born on February 18, 1932 in Philadelphia, Pennsylvania; and,

WHEREAS, Nat Anthony Agliano's parents Frank and Mary, immigrated from Italy in 1920 where his father worked as a laborer in the Philadelphia area and mother worked in clothing factories and later operated her own women's clothing store; and,

WHEREAS, in September 1945, the family moved to Monterey, California where **Nat Anthony Agliano's** parents obtained work in the enterprise fish cannery; and,

WHEREAS, Nat Anthony Agliano attended Monterey High School and Monterey Peninsula College, he graduated from UC Berkeley in January 1954 with a B.S. in Business Administration; and,

WHEREAS, in August 29, 1953, **Nat Anthony Agliano** married Lillian Bergren and had four children, Michael, Lisa, Cheryl and Julie; and,

WHEREAS, Nat Anthony Agliano was drafted and served two years in the United States Army where he was stationed at Fort Ord, California and then Fort Bliss, Texas; and,

WHEREAS, Nat Anthony Agliano attended Hastings Law School and graduated in 1959; and,

WHEREAS, following Law School, **Nat Anthony Agliano** was employed as a Deputy California Attorney General in the Criminal Division in Sacramento; and,

WHEREAS, after three years in the Attorney General's Office, **Nat Anthony Agliano** entered private practice in the Salinas office of Cunningham and Panelli, subsequently Panelli and Agliano, a general practice involving business, probate, family, personal injury and criminal law matters; and,

WHEREAS, Nat Anthony Agliano was appointed to the Salinas Municipal Court in October 1971, the Monterey County Superior Court in March 1972, Associate Justice, Court of Appeal, Sixth Appellate District in San Jose on November 1984, Presiding Justice of the Court In 1986, and retired from the Court of Appeal on February 18, 1992; and,

WHEREAS, since 1993, **Nat Anthony Agliano** has been employed exclusively and continuously as an arbitrator and mediator with Judicial Arbitration and Mediation Services.

NOW THEREFORE BE IT RESOLVED, that the Board of Supervisors of Monterey County, on behalf of the County and all its residents thereof, acknowledges and congratulates **Nat Anthony Agliano** as the recipient of the Justice Nat Agliano Lifetime Achievement Award by the Monterey County Bar Association.
