as "Winter Storm Preparedness Week in Monterey County"	)

**WHEREAS**, the risk of catastrophic storms and floods exists every year, and heavy winter storms often lead to dangerous flooding conditions such as river overflows, coastal storms, storm surges, and overflows of dams and other water systems; and

**WHEREAS**, communities and individuals usually have hours to days to prepare; however, flash flooding, mud flows, and debris flows can develop quickly often with little or no warning; and

**WHEREAS**, floods are the most common natural disaster in the United States, causing outages, disrupt transportation, and damage buildings; and

**WHEREAS**, past floods and winter storms have caused much damage and destruction within Monterey County; and

**WHEREAS**, flood preparedness and response activities are effective tools in protecting life and property vulnerable to flooding; and

**WHEREAS**, as part of the National and State Flood Preparedness Week effort, sponsored by the National Weather Service and California Department of Water Resources; and

**WHEREAS**, the National Weather Service and Monterey County have taken the steps necessary to maintain the status of Monterey County as a "StormReady!" county; and

**WHEREAS**, this Board finds it is necessary to inform the public of the possibility of flooding and other storm related hazards; and

**WHEREAS**, this Board finds it is necessary to inform the public of effective measures by which to mitigate and protect against winter storm hazards.

**WHEREAS**, this Board recommends the public participate in the 2021 Hazard Mitigation Update, with more information of how to do so on the County of Monterey, Office of Emergency Services website at: https://www.co.monterey.ca.us/government/departments-a-h/administrativeoffice/office-of-emergency-services/hazard-mitigation.
