WHEREAS, County Service Area 9 (CSA 9) is a non-contiguous district with three separate areas located just outside the City of Salinas: the Bolsa Knolls Community, Rogge Commons, and Country Club Meadows Subdivision are north of Salinas along San Juan Grade Road; Rosehart Industrial Park is south of Salinas along Potter Road;

WHEREAS, storm drainage, surface water disposition, and streetlighting are the active services within CSA 9;

WHEREAS, periodically, it is necessary for Special Districts to perform minor vegetation maintenance to allow for the free flow of stormwater in the County-maintained drainage areas;

WHEREAS, a series of streetlighting near the Rogge Road and San Juan Grade intersection has not been functioning, and it was determined that the wiring has been stolen;

WHEREAS, during the annual County Service Area (CSA) visual infrastructure inspections, completed in February 2019, several maintenance projects were identified and due to the timing of the FY 2019-20 Baseline budget development, these projects were not included in the FY 2019-20 Adopted Budget;

WHEREAS, it is necessary to increase the FY 2019-20 Adopted Budget appropriations in Fund 052, Appropriation Unit RMA048, by \$65,000, financed by Fund 052, Unassigned Fund Balance, Balance Sheet Account 3101, to fund the repair projects (4/5th vote required); and

WHEREAS, this action supports the County of Monterey Board of Supervisors Strategic Initiatives related to Public Safety and Infrastructure by completing the streetlighting and storm drainage projects, infrastructure will be restored to optimal functionality and enhance safety for vehicle and pedestrian travel.

WHEREAS, County Service Area 32 (CSA 32) is a non-contiguous district with three (3) separate subdivisions located along Langley Canyon and Moro roads in Prunedale, CA:

WHEREAS, streetlighting, storm drain maintenance, and surface water disposition are the active services for CSA 32;

WHEREAS, a storm drainage valley gutter on Langley Court, measuring approximately six-hundred feet (600'), needs substantial vegetation and sediment removal, and underground video will identify any areas where maintenance is needed in the downstream culvert;

WHEREAS, contingency funds of \$5,000, are allocated for this appropriation request in the event the culvert requires repair;

WHEREAS, during the annual County Service Area (CSA) visual infrastructure inspections, completed in February 2019, this maintenance project was identified, and due to the timing of the FY 2019-20 Baseline budget development, it was not included in the FY 2019-20 Adopted Budget;

WHEREAS, it is necessary to increase the FY 2019-20 Adopted Budget appropriations in Fund 066, Appropriation Unit RMA062, by \$10,000, financed by Fund 066, Unassigned Fund Balance, Balance Sheet Account 3101, to fund this repair project (4/5th vote required); and

WHEREAS, this project supports the County of Monterey Board of Supervisors Strategic Initiative related to Infrastructure as by completing the storm drainage maintenance project, infrastructure will return to optimal functionality.

WHEREAS, in County Service Area 45 Oak Hills-Open Space (CSA 45 Oak Hills-Open Space), the annual goat grazing vegetation management program, instituted in 2017, has been a highly effective vegetation control alternative well supported by the community;

WHEREAS, on June 18, 2019, the Board of Supervisors adopted Resolution No. 19-221 to amend the CSA 45 Oak Hills-Open Space FY 2018-19 Adopted Budget to allow funding for a goat-grazing project at the end of FY 2018-19;

WHEREAS, because of vendor scheduling difficulties due to weather and lack of available goat herds, the project was postponed to July 2019;

WHEREAS, additional appropriations are needed to fund the July 2019 activity and anticipated Spring 2020 goat-grazing projects;

WHEREAS, it is necessary to increase the FY 2019-20 Adopted Budget appropriations in Fund 075, Appropriation Unit RMA071, by \$35,000, financed by Fund 075, Unassigned Fund Balance, Balance Sheet Account 3101, to fund this project (4/5th vote required); and

WHEREAS, this Project meets the County of Monterey Board of Supervisors Strategic Initiatives related to Public Safety and Health & Human Services as effective management of open space vegetation by reducing the fuel source lowers the risk of wildfire, and access to cleared areas encourages the community to be active outdoors.
