

- DA Overtime Augmentation Request: \$34,064

- Consideration:
 - \$250,000 Overtime held in Cannabis Program budget
 - To be used as a draw
 - Sheriff's Office will exhaust \$200,000 OT currently in FY 19-20 budget first before requesting draw.



Chapter 7.90 of the Monterey County Code

- Sets requirements to obtain a commercial cannabis permit, and operating requirements once a permit is approved.
- It is an annual permit.
- The permit is obtained by a business after all necessary land use entitlements are approved for the property.
- The County's commercial cannabis tax is based off the square footage listed in the permit.



- Changes in administrative review of the permit
- The California Cannabis Authority is now collecting data
- The California Department of Food & Agricultural, the Bureau of Cannabis Control, and the Department of Public Health all adopted final permanent regulations in January 2019
- For consistency with the Monterey County Code

Proposed Chapter 7.90 Amendments



County administrative changes:

- Make Cannabis Program Manager the Appropriate Authority
- Allow permit to be modified once to change square footage
- Allow permit to be modified three times for other changes
 - Allow the permit to be modified if there is a partial change in ownership
- Require applicants who hold a State provisional license to submit application within 30 days of final approval of land use entitlement
- Require applicants to provide GPS coordinates
- Require diagram of proposed total canopy area and max amount of SF of cultivation

California Cannabis Authority:

• Require that all permittees submit information to CCA

Proposed Chapter 7.90 Amendments



Changes to state law and Monterey County Code:

- Add necessary language given that outdoor pilot program approved
- Add definitions of "owner" and "financial interest"
- Remove distinction between A-type and M-type permits
 - Designation to be placed on County permit
- Require all property owners, business owners, and employees:
 - To be 21 years of age or older
 - To wear an identifying badge provided by permittee
- Better define surveillance requirements
- Change odor requirements

Cannabis Committee Direction



- Draft ordinance presented to CC on September 30th
- Approved draft ordinance with certain amendments:
 - Allow business with partial change in ownership to modify permit to align with state law
 - Modify once based on SF, more times for other changes
 - Hold a workshop re. CCA requirements
- Public brought up issue of creating an exception for R&D
 - No exception now for R&D, but evaluate issue when amending Chapter 7.100 (commercial cannabis tax)

Timeline and Direction



Introduce, waive reading, and set November 5, 2019 at 10:30 a.m. as the date and time to consider adoption of an ordinance amending Chapter 7.90 of the Monterey County Code to streamline administrative processes of the commercial cannabis permit, and better align the Chapter to state law and other portions of the Monterey County Code.
