WHEREAS, The Resource Management Agency (RMA) is the lead for managing capital projects for County facilities (e.g., roads, bridges, buildings, parks, and grounds);

WHEREAS, on June 19, 2019, the Board of Supervisors adopted a resolution approving the County of Monterey Five-Year Capital Improvement Program for FYs 2019/20 through FY 2023/24 (CIP);

WHEREAS, the approved CIP prioritizes County facility projects essential to maintain and improve County infrastructure and facilitate the orderly implementation of the County General Plan;

WHEREAS, in August 2019, the County Administrative Office (CAO) requested that the RMA develop a comprehensive project listing summarizing all facility project needs;

WHEREAS, by providing this comprehensive list of RMA project needs, the Board of Supervisors can see the overall funding needs to make an informed decision regarding the use of Fund 402 Unassigned Funds as the potential financing source;

WHEREAS, RMA staff developed this list based on its understanding of Board direction and with input from the Capital Improvement Committee (CIC) and Budget Committee (BC);

WHEREAS, This comprehensive listing includes several added projects that were either excluded from the approved CIP, were approved but not funded, were projects that leverage outside funds, or were identified after the FY 2019/20 RMA CIP Budget was adopted;

WHEREAS, an amendment to the RMA Fiscal Year 2019/20 Work Program is required to add the selected Facilities projects totaling \$1,752,167;

WHEREAS, the Budget Committee supported the use of Fund 401 Unassigned Fund Balance, with a then balance of \$2,808,994, as the funding source for the added projects;

WHEREAS, during the development of Fiscal Year 2019-20 Adopted Budget, RMA in collaboration with the CAO and Auditor-Controller's Office, it was determined that 1) Fund 401, Facilities Projects Maintenance, would be dissolved and that facilities maintenance projects not considered capital projects would be performed out of the Fund 001 Facilities Maintenance budget; 2) Projects qualifying as Capital Projects would be performed either out of Fund 402, Capital Projects, or Fund 404, Facility Master Plan Projects;

WHEREAS, The FY 2019/20 Adopted Budget distributed the Fund 401 Unassigned Fund Balance as an Operating Transfer-In to the following funds: \$2,820,015 Fund 402, Capital Projects; \$43,868 toward the Carmel River Scenic Road Protection Structure Project in Fund 404, Facilities Master Plan Projects; and \$258,565 toward completion of the Energy Efficiency Measures Phases IV and V in Fund 001, Facility Maintenance;

WHEREAS, of the \$2,820,015 transferred to Fund 402, \$350,000 has been set aside for prior year projects that carried over into FY 2019/20 (Parkfield Library \$150,000; Bradley Library \$200,000), and \$656,893 toward the Homeless Emergency Aid Program (HEAP) Grant to build the 855 Laurel Drive Homeless Shelter, leaving a remaining balance of \$1,813,122;

WHEREAS, RMA is recommending that the Fund 402 Unassigned Funds derived from the transfer of the Fund 401 Unassigned Fund Balance of \$1,752,167 be used toward the remaining six (6) identified projects leaving an unassigned balance of \$60,955; and

WHEREAS, this recommendation supports the Board of Supervisors Strategic Initiatives for Economic Development, Administration, Health & Human Services, Infrastructure, and Public Safety as provision of adequate County facilities and infrastructure increases accessibility and safety, enhances the work environment for County staff and accommodations for occupants, and improves the quality of life for County residents while supporting economic development.
