CAO020, of \$157,523 (4/5 th vote required))

WHEREAS, the County is required to maintain permits and perform mandated monitoring and reporting activities for eleven (11) closed landfills and two (2) lift stations;

WHEREAS, all closed landfill sites require permitting and at certain landfill sites, state and federal laws mandate additional postclosure monitoring and reporting activities including, but not limited to, annual water quality monitoring, preparation and implementation of Storm Water Pollution Prevention Plans (SWPPs), wet weather monitoring well inspections and reports, biannual dry weather inspections, and stormwater collection and analysis;

WHEREAS, RMA engages a consultant for their specialized expertise and required credentials to perform mandated monitoring and reporting activities for County closed landfills;

WHEREAS, additional mandated reporting and monitoring requirements have been identified for four closed landfill sites (Lake San Antonio-North Shore, Lake San Antonio-South Shore, Bradley, and San Ardo) involving additional consultant services at an estimated cost of \$157,523;

WHEREAS, these additional requirements were not anticipated when the annual budget was prepared, so they are not included in the Fiscal Year 2019-20 Adopted Budget for Fund 001-Closed Landfills;

WHEREAS, an amendment to the FY 2019-20 Adopted Budget for County Disposal Sites, General Fund 001, Unit 8175, Appropriation Unit RMA039, is needed to increase appropriations to cover the full costs for closed landfill regulatory compliance reporting and to perform necessary refreshment and replacement of Best Management Practices (BMPs) existing measures, including silt fences, straw matting, and straw waddles;

WHEREAS, the recommended action will increase appropriations in the amount of \$157,523 in Fund 001, Appropriation Unit 8175, Appropriate Unit RMA039, financed by an operating transfer from General Fund Contingencies, Fund 001, Appropriation Unit CAO020, of \$157,523; and

WHEREAS, the requested appropriation for Closed Landfills adheres to numerous Monterey County Board of Supervisors' Strategic Initiatives as required reporting, sampling, and maintenance conforming to Best Management Practices ensure that closed landfills maintain their integrity and pose no contamination risks to the environment or public safety.
