The Central Coast Broadband Consortium (CCBC) strongly supports Charter Communications' request to have its Coast Development Permit application (PLN190010/Charter Spectrum) granted pursuant to a CEQA negative declaration. The CCBC is the CPUC's designated Regional Broadband Consortium representing Monterey, San Benito and Santa Cruz counties. We receive funding from the California Advanced Services Fund to support the development of broadband infrastructure and service in our region.

This permit is necessary for Charter to meet the obligations imposed on it by the California Public Utilities Commission, following the County of Monterey's intervention in Proceeding A 15-05-007 regarding the acquisition of Time Warner Cable and Bright House Networks by Charter. The County of Monterey, supported by the CCBC, negotiated and executed a memorandum of understanding dated February 10, 2016 which requires Charter to, among other things, upgrade broadband service in Carmel Highlands and along the State Route 68 corridor. In Decision 16-05-007, the CPUC ordered Charter to "abide by all the terms and conditions of the agreements with the County of Monterey". The deadline for complying with this order was May 18, 2019.

Subsequently, as described in Resolution T-17589, the CPUC reviewed the specific circumstances of Charter's planned work along State Route 1 and "consulted with the Caltran's Landscape Architect for District 5 and conclude[d] that the project will not damage scenic resources along a state scenic highway". The CPUC formally found that "the project is categorically exempt from CEQA review because it meets the criteria for the CEQA Guidelines Section 15301 'existing facilities' exemption and the CEQA Guidelines Section 15303 'new construction of small structures'".

We respectfully request that this permit be granted without delay, so that Charter may meet its obligations to our community, as obtained by the County of Monterey through its intervention at the CPUC.
