Hi Eric,

MPWMD manages the water supply and process Water Permits for all properties within its boundaries. The Hidden Hills neighborhood is served by a system known as Carmel Valley Mutual, a water company that was purchased by Cal-Am some years ago. The system currently has water available for new connections and additions. MPWMD will process a Water Permit application for a new connection when a complete approved set of construction plans is submitted with a signed application.

Please be aware that Cal-Am did file for a proposed moratorium in the Hidden Hills, Bishop and Ryan Ranch systems of Cal-Am. It has to go through an approval process with the PUC, which may take anywhere for 5 months to 18 months. If its approved before you set your meter for your project it would prevent you from getting a connection to the system for your lot.
